有關 貴局果斷採取措施，迅速銷毀雞隻，防止禽流感蔓延。本會表示支持及欣賞。

政府將會要求立法會財務委員會撥款，給予雞農、批發商、零售商及運輸商賠償。本會認為同時應對有關的從業員作出合理的補償，雖然 貴局表示對業界的財政協助方案，與 97 年禽流感事件相同。但當年殺雞事件已發生了部份東主獨吞全部津貼，使工人一無所有，陷入困境的事例。政府為何不吸取教訓，將原定的特惠補償分開，讓東主及工人均可獲得同樣合理的補償？！

為了特惠補償的公平合理分配，必需照顧受殺雞行動影響的工人。以上意見請認真考慮。
