Action

Members agreed that the Bills Committee would scrutinize the English version of CSA proposed by the Administration. The LegCo Legal Service Division (LSD) was requested to examine the Chinese version of CSA and follow up with the Law Draftsmen on drafting and other technical matters. In the event that there were unresolved issues, LSD would raise them at meetings.

2. The Bills Committee deliberated (Index of proceedings attached at the **Annex**).

Admin 3. The Administration undertook to take follow-up actions in respect of SFB as follows:

- (a) to consider drafting comment in relation to the word “to” at the beginning of clause 5(1);
- (b) to consider whether it would be appropriate to put the titles listed under clause 34(1) to a separate schedule to SFB to facilitate amendment in the future;
- (c) to review the use of the term “issue” and to consider whether it would be appropriate to replace it by “issuing” in various provisions in Part IV;
- (d) to consider where appropriate to replace the word “purposes” by ‘purpose’ in various provisions in Part IV;
- (e) to review the drafting of clause 106(1)(a) and to consider deleting clause 106(1)(b);
- (f) to review the phrases “not capable of being fulfilled” and “not capable of being justified” in clauses 106 and 107;
- (g) to review the phrase "with the result that" in clauses 106 and 107;
- (h) to consider deleting clause 107(1)(b);
- (i) to consult licensed corporations on draft rules on insurance coverage for licensees and to inform them of the new arrangements as early as practicable;
- (j) to consider replacing the word “him” by “his” in clause 120(2)(d);
- (k) to consult the market on other particulars, such as disciplinary sanctions imposed, to be contained in the register on licensed persons and registered institutions under clause 133;
- (l) to review the drafting of clause 161A in relation to the word “notification”; and
- (m) to review the use of “lawful excuse” and related drafting in clause 167.

4. As the Bills Committee had completed scrutiny of CSA on Parts I to VII and the relevant Schedules, members agreed to cancel the meeting scheduled for Thursday, 6 December 2001. The next meeting would be held on Monday, 10 December 2001 at 8:30 am.
