### **NOISE CONTROL (AMENDMENT) BILL 2001**

#### **INTRODUCTION**

At the request of Members at the first meeting of the Bills Committee held on 21 February 2002, the following information is provided -

- (a) details of prosecution and conviction cases involving breaches of the Noise Control Ordinance (NCO) during the three years between 1999 and 2001 including the names of the defendants, the dates of convictions, the nature of the offence and the level of fines;
- (b) examples of provisions in other Ordinances imposing a personal liability on directors/officers for offences committed by their bodies corporate;
- (c) the existing enforcement practice under section 6(5) of the NCO, in particular whether a body corporate would be prosecuted more than once each day in respect of a continuing contravention.

#### **Previous Prosecution and Conviction cases under the NCO**

2. Arising from prosecutions brought by the Environmental Protection Department (EPD), there were a total of 1 160 convictions under the NCO between 1999 and 2001. Details of these conviction cases including the repeat offenders (those who have been convicted 5 times or more) as referred to in paragraph 4 of the Bills Committee Paper No. 1 are set out at Annex A.

### **Existing Provisions imposing Personal Liability on Directors/officers**

3. Annex B sets out the examples of Ordinances which impose personal liability on directors/officers for offences committed by their bodies corporate. The persons to be held liable in these provisions are mostly “director, manager, secretary or other similar officer of the body corporate or any person who was purporting to act in any such capacity.” The expression “concerned in the management of the body corporate” which is adopted in the proposed section 28(A) of the Noise Control (Amendment) Bill 2001 (the Bill) also appears in the Criminal Procedures Ordinance (Cap. 221), Air Pollution Control Ordinance (Cap. 311) and Waste Disposal Ordinance (Cap. 354) etc.

### **Existing Enforcement Practice under Section 6(5)**

4. In enforcing section 6 of the NCO, if an offence is spotted at a construction site, officers of the Environmental Protection Department (EPD) would observe and record particulars of the construction activities in violation of the NCO as evidence. The officers would then approach the person-in-charge of the site to collect further evidence. The person-in-charge would be asked to stop the violation and warned that prosecution action would be initiated for the offence spotted. EPD would subsequently review the evidence collected and lay summons against the offenders as appropriate.

5. It is the existing practice that separate summonses would be laid for construction activities which are found to be in violation of different provisions of the NCO on the same day or on different days. If a body corporate commits the same offence intermittently on the same day, i.e. during different periods of the day, only one summons would be laid but the intermittent pattern would be stated in the brief facts and/or adduced in court. If the body corporate is convicted, the court will take this intermittent pattern into account when determining the sentence.

6. Section 6(5) of the NCO provides for a fine of \$20,000 for each day during which the offence continues. If the evidence shows

that the same offence was committed under the same provision of the NCO, for example, the same kind of powered mechanical equipment is used without a permit for the same kind of construction work on consecutive days, the period in which the offence was committed will be stated in the information presented to the court so that the court can impose a daily fine if it considers it appropriate.
