#### I. Confirmation of minutes

[LC Paper No. CB(2)1138/01-02]

The minutes of the meeting held on 15 January 2002 were confirmed.

## **II.** Meeting with the Administration

[LC Paper No. CB(2)1136/01-02(01)]

2. The Committee deliberated on the Administration's response to members' questions raised at the last meeting in respect of restraint orders [paragraphs 1 to 24 of LC Paper No. CB(2)1136/01-02(01)] (Index of proceedings attached at **Annex**).

- 3. Members appreciated that there was a need to prevent the person who had been arrested and released on bail from dissipating his property such that no property would be available to satisfy a confiscation order if one was made in his case. To protect the property's right of a person who should be presumed innocent before any conviction, members considered that it was necessary to strike a balance by raising the threshold for invoking the power to restrain the property of a person who had been arrested and released on bail. The Administration was requested to consider the feasibility for the Court to apply a lower threshold to make a restraint order for a limited period of time and to apply a higher threshold if that period of time was to be extended.
- 4. To address members' concerns, the Administration had suggested to add a condition to the amended section 9(1)(ba) of the Drug Trafficking (Recovery of Proceeds) Ordinance (Cap. 405) and amended section 14(1)(ba) of the Organized and Serious Crimes Ordinance (Cap. 455) to the effect that the Court of First Instance must also be satisfied that a holding charge could not be laid in that case.
- 5. <u>The Chairman</u> requested the Administration to consider the feasibility of the two foregoing suggestions (including their merits and demerits) and provide a discussion paper for members' consideration at a future meeting.

### III. Any other business

- 6. <u>Members</u> agreed that the Committee would continue discussion on the Administration's response to members' questions raised at the last meeting in respect of confiscation orders [paragraphs 25 to 28 of LC Paper No. CB(2)1136/01-02(01)] at the next meeting to be held on Wednesday, 27 February 2002 at 8:30 a.m.
- 7. There being no other business, the meeting ended at 6:00 p.m.
