Members noted that the Administration had prepared draft Committee Stage amendments (CSAs) to address members' concerns about proposed sections 25 and 25A of the Drug Trafficking (Recovery of Proceeds) Ordinance and the Organized and Serious Crimes Ordinance. Since the Administration had not finished the consultation with relevant professional bodies and the legal profession on the draft CSAs, and the proposals regarding sections 25 and 25A were quite separate from those in the rest of the Bill, it was therefore proposed that the Bills Committee should discuss proposals in respect of provisions other than sections 25 and 25A. The Committee deliberated and decided that discussion should not be continued until the Administration was ready to revert to the Bills Committee on sections 25 and 25A (Index of proceedings attached at **Annex A**).
