I. Meeting with Karaoke Requirements Concern Group and the Administration

(LC Paper Nos. CB(2)2358/00-01(01), CB(2)376/01-02(01)-(02) and CB(2)1204/00-01(01))

The Committee deliberated (Index of proceedings attached at **Annex A**).

2. Assistant Director/New Buildings (1) advised members that at a meeting with representatives of the Karaoke Requirements Concern Group (Concern Group) on 9 November 2001, the Concern Group had requested the Administration to consider the following requests -

- (a) to tolerate corridor width of less than 1.2m, if the reduced corridor width was not less than 1.05m as a result of installation of fire resistance partition wall;
- (b) to consider alternative options in resolving the dead-end problem, if an existing karaoke establishment had genuine difficulty in providing an access panel giving access to the adjacent room; and
- (c) to further extend the 36 months' grace period for upgrading works to install partition wall having a fire resistance period of one hour in corridors.

The Administration agreed to revert to the Bills Committee on its position on the requests of the Concern Group in two to three weeks' time.

II. Date of next meeting

3. As the Administration had yet to reply to the outstanding issues raised by the Bills Committee at its meetings on 18 May, 9 and 22 October 2001, members agreed that the next meeting scheduled for 16 November 2001 be cancelled. The next meeting would be held at 2:30 pm on 29 November 2001.

4. There being no other business, the meeting ended at 12:55 pm.
