Ms Cyd HO was elected Chairman of the Bills Committee.

- 2. The Committee deliberated (Index of proceedings attached at **Annex**).
- 3. The Administration briefed members on the background of the Bill and confirmed that -
 - (a) the Bill did not seek to affect substantially the existing operation of the Ordinance (except for the appeal mechanism provided); and
 - (b) the "Guide and Syllabus" would be submitted to LegCo for Members' perusal and the Labour Department would consider Members' views on the "Guide and Syllabus".
- 4. <u>The Chairman</u> suggested that members representing the labour sector might wish to consult the employees of the relevant trade, if necessary, concerning the issue, endorsement and revocation of certificates. She also requested the Administration to briefly explain the operations of the different types of boilers and pressure vessels, and the associated risks, at the next meeting.
- 5. After going through issues covered by the Bill, the Committee commenced clause-by-clause examination of the Bill and completed scrutinising the proposed section 6(1) in clause 2 of the Bill.
- 6. The Administration was requested to provide information on the following -
 - (a) The intended meaning and the criteria of being a "fit and proper" person under the proposed subsection 6(1)(b)(i); and whether there were different connotations of the expression "fit and proper" under other laws;

- (b) To consider substituting the expression "fit and proper" with "suitable" and providing a definition of "suitable person" under section 2 of the principal ordinance;
- (c) To explain the qualifications, experience and knowledge required for the issue of certificates under the two different circumstances, i.e. with or without sitting and passing the examination;
- (d) To explain the objective standards for determining whether a candidate needed to sit an examination for the issue of a certificate of competency;
- (e) The measures for the employer and the Labour Department to verify whether a certificate is still valid, e.g. whether the holder had not been engaged in the operation of the type of boiler or steam receiver as specified in his certificate for a period of 4 years or more;
- (f) To spell out in the Bill the two-tier appeal mechanism for dealing with appeals, e.g. against revocation of certificates under section 6(4)(b);
- (g) Whether there were sufficient certificate holders to operate the existing boilers and pressure vessels, and the number of boilers and pressure vessels which were operated for a continuous period of more than 8 hours everyday;
- (h) The measures adopted by the Labour Department to ensure that such boilers were always operated under the direct supervision of a certificate holder; and
- (i) To consider reducing the fees for the issue or endorsement of a certificate as there had been a downward price adjustment since the last review of fees and charges under the Ordinance conducted in 1997.
- 7. The Committee agreed to hold the next two meetings on 27 February 2002 at 8:30 am and 12 March 2002 at 10:45 am.
- 8. There being no other business, the meeting ended at 12:35 pm.
