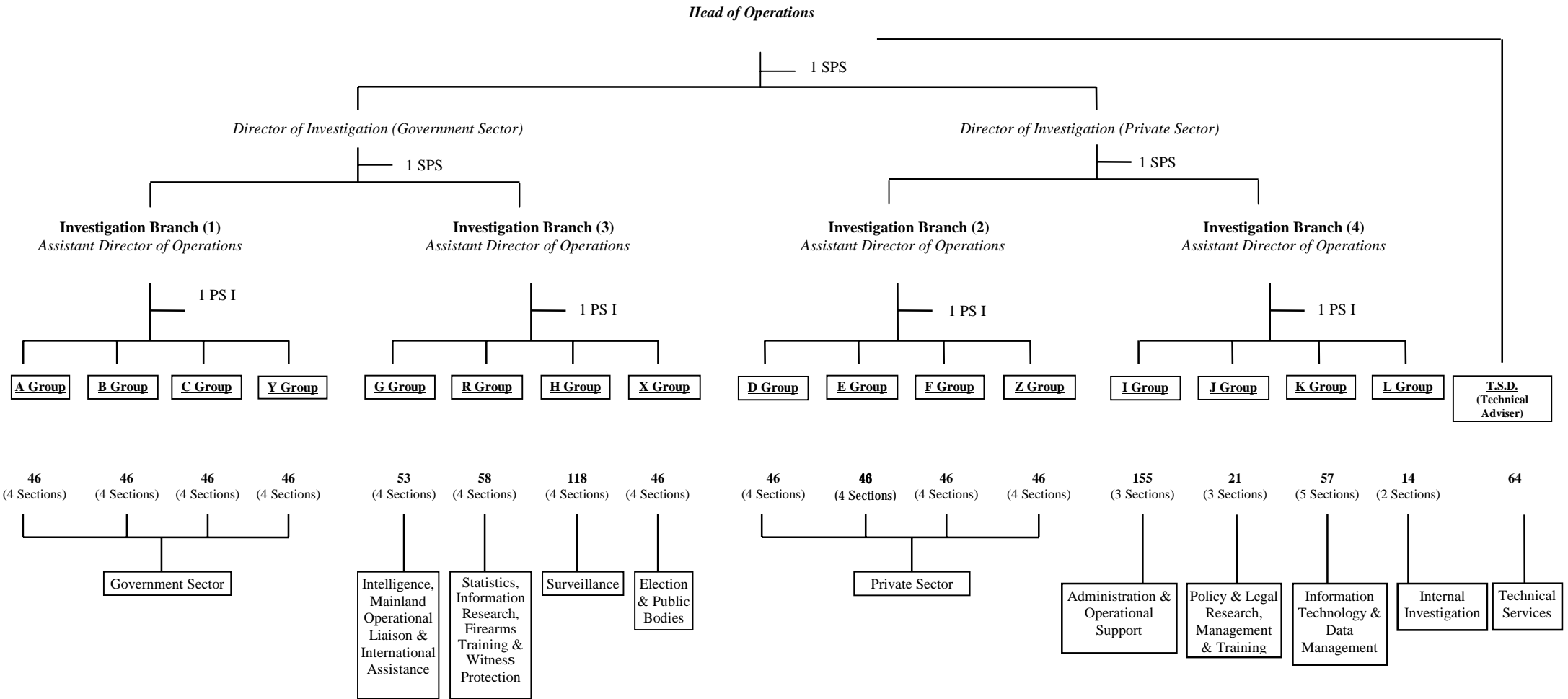

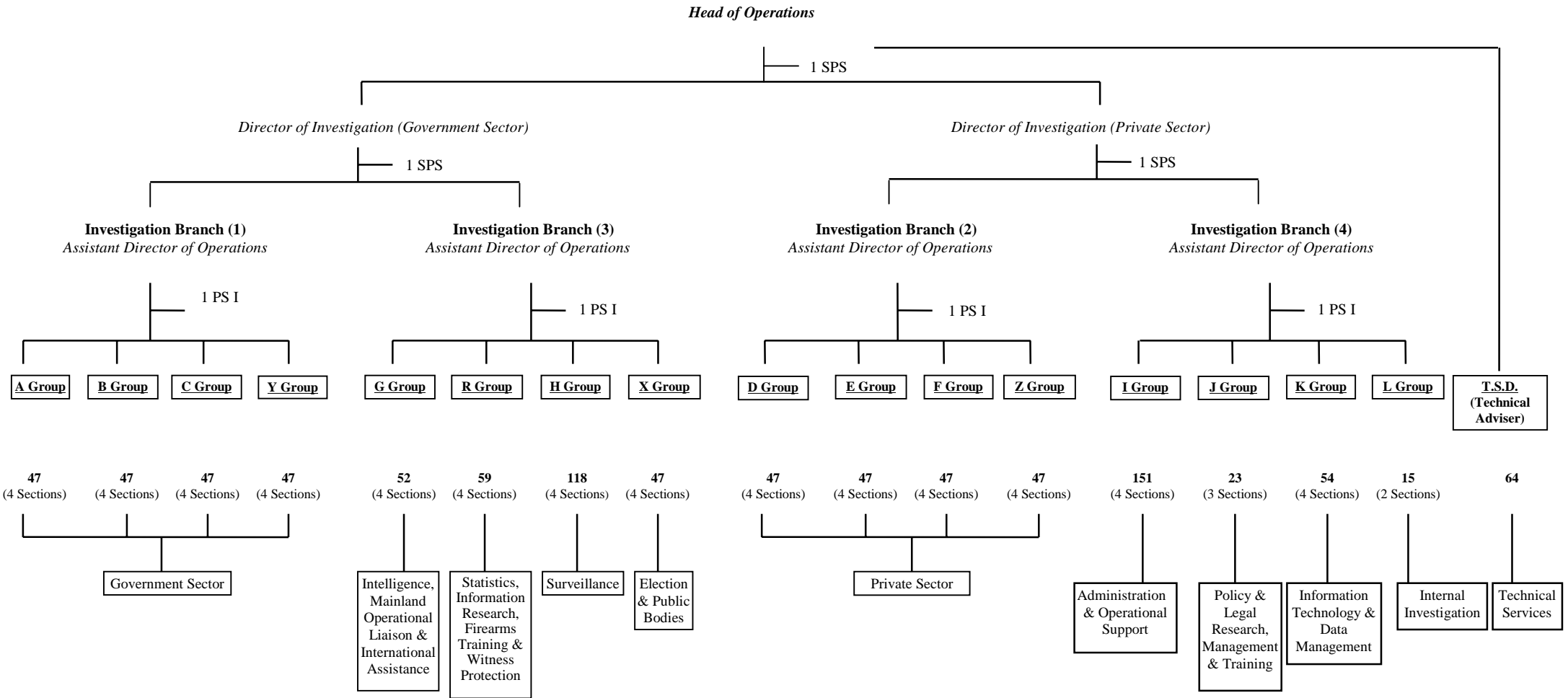

Reply:

The ICAC has been attaching much importance to corruption prevention work for the construction industry. A task force comprising officers with knowledge of the industry from the Operations, Community Relations and Corruption Prevention Departments was established in April 2000 to study and analyse problems prevailing in the industry and to co-ordinate corruption prevention training for construction industry practitioners. In 2000–01, about 500 training talks were organised, of which about 120 were for site supervisors of the Housing Department and consultant firms on government's approved lists.

In 2001–02, the ICAC will redeploy 20 experienced officers to continue with this area of work. We shall redeploy additional manpower, if necessary.

(1) when will this plan be implemented;  
(2) the establishment of this team after formalisation and its scope of responsibilities; and  
(3) what amount of expenditure will it incur?

Reply:

- (1) Formalisation of the establishment of the Quick Response Team (QRT) will be implemented on 1 April 2001.
- (2) The establishment of QRT will comprise 11 posts, including 1 Chief Investigator, 2 Senior Investigators / Investigators and 8 Assistant Investigators.

QRT will be tasked to investigate complaints of a minor nature which appear capable of quick resolution. The consistently high number of corruption reports and caseload, coupled with the sophistication of many of these cases have subjected the Operations Department to enormous work pressure. After formalising the establishment of QRT, which is currently staffed by internal re-deployment of investigative resources, investigation sections will be brought back to their original strength to tackle cases of substance and complexity.

- (3) It will incur \$4 million.
