| 126WC PWSC(2001-02)23 (Head 711) | Water supply to housing developments at Anderson Road, near Choi Wan Road and Jordan Valley | To recommend to Finance Committee - (a) the upgrading of part of 126WC as 127WC , entitled “Mainlaying within development near Choi Wan Road and Jordan Valley”, to Category A at an estimated cost of \$79.9 million in money-of-the-day prices; and (b) the retention of the remainder of 126WC in Category B. |
| 746TH PWSC(2001-02)26 (Head 706) | Reconstruction and improvement of Tuen Mun Road | To recommend to Finance Committee - (a) the upgrading of part of 746TH as 755TH , entitled “Reconstruction and improvement of Tuen Mun Road – investigation and preliminary design”, to Category A at an estimated cost of \$37.8 million in money-of-the-day prices; and (b) the retention of the remainder of 746TH in Category B. |
