

## NOTE FOR FINANCE COMMITTEE

### Changes to the Approved Estimates of Expenditure Approved under Delegated Powers

In accordance with the Public Finance Ordinance section 8(8)(a), the Financial Secretary shall at the end of each quarter of the financial year or as soon as practicable thereafter report to the Finance Committee changes made to the approved estimates of expenditure in that quarter upon approval by him or by any public officer pursuant to a delegation under section 8(3) or (4). This note contains details of such changes made during the second quarter of 2000-01.

Encl. 2. During the second quarter of 2000-01, 23 applications for supplementary provision, four applications for increases in commitments, 23 applications for new commitments, 16 applications for commitments revoked, one application for changes in title of approved commitments and a net decrease of 4 773 posts, as detailed in the Report at the Enclosure, were approved under delegated powers.

3. The total additional funds required in the 23 applications for supplementary provision amounted to \$273,202,000. A breakdown is as follows -
