Question : To prevent the spread of foot and mouth disease, the Administration deploys 1 Senior Veterinary Officer and 2 Veterinary Officers to prevent the disease. The veterinary officers are supported by 22 laboratory and 11 field personnel. What support do these 11 field personnel provide? Will consideration be given to increase the manpower to provide more support?

Reply :

The 11 field staff conduct regular checks on livestock farms for animal diseases, in particular foot and mouth disease. They conduct surveys on specific diseases, collect samples required for disease surveillance and provide advice to farmers on farm hygiene, disease control and prevention. They also assist veterinary officers in investigating disease outbreaks.

If we identify a need to do so, e.g. in case of a disease outbreak, we will re-deploy existing resources accordingly.

Question : Each year, the government spends a large amount of resources on replanting trees in the urban areas as green work. In 2001-02, some \$26 million will be spent on planting of over 2.8 million plants in all 18 districts. Meanwhile, the Culture Committee is conducting consultation on how to enhance the cultural tinge of the townscape of Hong Kong. On the other hand, the government permits the continuous felling of numerous hundred-year old trees of historical, cultural and tourism value such as banyan trees rooted in the cracks of rocks. This is obviously a divergence in policy. Will the Agriculture, Fisheries and Conservation Department increase resources for protection of valuable or special plants in the urban areas, including providing additional resources for conducting systematic surveys on special trees in the urban areas, keeping data records of them, labelling them, giving special protection to them and enacting legislation to protect them and so on?

Reply :

The Agriculture, Fisheries and Conservation Department's main responsibility is to plant, maintain and protect vegetation inside country parks and special areas. As regards the urban areas, the Leisure and Cultural Services Department has embarked on a tree survey in 2000 to collect information on urban trees under its management and is establishing a database to record the relevant information collected such as species, dimensions, habitat and growing habit. This work will be covered by the existing resources of the Leisure and Cultural Services Department.

Question: The EPD indicated that the annual throughput of chemical wastes handled in the Tsing Yi Chemical Waste Treatment Centre (CWTC) was about 63,000 tonnes in 1999-2000 and in this year. According to the EPD's annual report, information shows that the construction cost of the said CWTC was \$1.3 billion, with a handling capacity of 100,000 tonnes chemical wastes a year and an estimated annual operating expenditure at \$500 million. Please advise:

- (1) since the commissioning of the CWTC in 1993, what is the annual throughput of chemical wastes handled?
- (2) has the Government over-estimated the quantity of chemical wastes in Hong Kong, and wasted the tax payers' money in constructing and maintaining such CWTC? and
- (3) is it cost effective to spend \$500 million a year for the handling of 63,000 tonnes of chemical wastes, with an average unit handling cost of \$8,000 per tonne?

Reply :

- (1) The annual throughput of the Chemical Waste Treatment Centre (CWTC) since 1993 is as follows:

Year	1993	1994	1995	1996	1997	1998	1999	2000
Intake in tonnes	22,200	81,000	89,300	64,400	68,900	74,700	62,200	62,800

- (2) In 1994 and 1995, the throughput was approaching the design capacity of 100,000 tonnes per year. The general decrease in the amount of waste going to the CWTC in subsequent years is due to a combination of the adoption of waste minimization practices and in-house treatment by some major chemical waste producers together with the overall change in Hong Kong's economic structure which has resulted in fewer manufacturing activities within Hong Kong. The Government is negotiating with the contractor to improve cost-effectiveness and reduce the net operating cost of the CWTC.
- (3) The services provided by the CWTC include pre-acceptance analysis, provision of suitable containers, waste collection and proper treatment that meet stringent emission requirements. The cost of chemical waste treatment in Hong Kong is comparable with that in the U.S.A., Canada, Denmark or Japan.

Regarding the collection of pig carcasses, the Food and Environmental Hygiene Department has designated 78 collection points. Where are these collection points located? Are they located in the proximity of the pig farms? Will the Government step up inspections of those vacant areas near pig farms to prevent unauthorised disposal of pig carcasses?

Reply :

The locations of the 78 designated collection points are set out at the **Annex**. All collection points are accessible by vehicles and within a few minutes' drive from pig farms. Some of them are within walking distance.

The most effective way to prevent unauthorized disposal of pig carcasses is to secure pig farmers' co-operation. We will work with AFCD to achieve this.

Reply :

Of the 80 hawker blackspots, 13 have existed for less than one year and two have existed for one to three years. The remaining 65 have been in existence for over three years.

Since the establishment of the Department on 1 January 2000, we have taken intensive and sustained action against illegal hawkers at hawker blackspots, and succeeded in bringing down the number of such blackspots substantially from about 120 in early 2000 to 83 by the end of 2000. We will keep up our efforts to contain and reduce further illegal hawking activities throughout the territory. We do not consider it realistic to set a time-table for eliminating hawker blackspots.
