Question : How much resource has the Administration provided to support the operation of the Transport Advisory Committee?

Asked by : Hon Mrs Miriam LAU Kin-ye

Reply : The Administration provides secretariat support to the operation of the Transport Advisory Committee (TAC) and the Transport Complaints Unit (TCU). The TAC Secretariat is headed by a Principal Assistant Secretary. He is supported by 19 staff, including a Senior Administrative Officer, a Chief Executive Officer, a Senior Executive Officer and four Executive Officers. The TAC Secretariat is also responsible for assisting the Committee in conducting research on specific transport issues.

Over the past two years, \$350,000 was spent on computerising the TCU complaints handling and processing system to improve the efficiency and effectiveness of the Unit. Separately, \$53,000 was spent on providing training courses to 12 staff of the TAC Secretariat to improve their skills and efficiency in handling complaints. In 2001-02, about \$300,000 is earmarked for publicizing the work of the TAC and the TCU.

Question : How many meetings of the Cross-Boundary Infrastructure Co-ordinating Committee (ICC) have been held since 1 July 1997?

Reply : The ICC, which succeeded the former Sino-British Coordinating Committee on Major Cross-Border Infrastructure between Hong Kong and the Mainland, was inaugurated on 16 October 1997 and under its purview there were four Panels and one Expert Group, namely the Roads and Bridges Panel, the Railway Panel, the Air Traffic Control Panel, the Panel on Marine Channels and the Expert Group on Huanggang - Lok Ma Chau Passenger Crossing.

Under the ICC, the implementation of the cross-boundary infrastructural development programmes has been followed up by the relevant Panels and Expert Group.

Question : How many applications by franchised bus operators for introduction of new bus routes on Hong Kong Island were rejected in the past year?

Asked by : Hon Emily LAU Wai-hing

Reply : Under the Public Bus Services Ordinance, a franchised bus operator is required to submit a Route Development Programme (RDP) which includes proposals for new routes to the Transport Department for approval. In examining proposals for new bus routes, we will consider carefully the service need for these routes as well as the need to ensure efficient use of existing bus resources and limited road space and avoid unnecessary duplication.

At present, a total of 196 bus routes are operating on Hong Kong Island. With regard to the RDP for 2000-01, we received applications from the franchised bus operators to introduce 11 new routes on Hong Kong Island. After discussion with the concerned operators and taking into account the outcome of consultations with the relevant District Councils, we approved one new bus route for introduction in 2000-01. The other applications were not approved because of a number of reasons, which include –

- (a) the demand does not justify the provision of the proposed new routes;
- (b) the demand can be served by the existing and committed public transport services in the areas concerned;
- (c) the need to avoid routing through the congested corridors; and

(d) the need to minimize duplication with the existing public transport services.

Question : How many people are now living in NT small houses? What is the existing policy on the provision of emergency vehicular access (EVA) for small houses? Does the Administration have any plans to improve the EVA arrangements for NT small houses?

Asked by : Hon LAU Ping-cheung

Reply : According to information provided by the Planning and Lands Bureau, it is estimated that at present about 400,000 people are living in New Territories Exempted Houses (NTEH), which include small houses granted to indigenous villagers.

The requirement of emergency vehicular access (EVA) applies to NTEH. The existing policy is that for ten or more NTEH developments in a cluster, there should be an EVA to allow emergency vehicles to reach within 30 metres from any building. Such EVA should not be less than 4.5 metres in width with a headroom clearance of 4.5 metres and should be capable of withstanding the loading of 16 tonne fire appliances. Standard pedestal type fire hydrants should be provided along the EVA at 100m intervals.

For a development fewer than ten houses in a cluster, whether or not to impose the EVA requirement will depend on local circumstances and development potentials. The relevant District Lands Office, in consultation with the Fire Services Department, will carefully consider each application on its own merits.
