Chapter 327 Section 31	Lifts and Escalators (Safety) Ordinance Liability of directors, etc. where offence committed by company	
Chapter 60 Section 36A(1)	Import and Export Ordinance Offences by directors, partners, etc.	Where an offence under section 36 is committed by a body corporate, every person who, at the time of the commission of the offence, was a director, manager, secretary or other similar officer of the body corporate or any person who was purporting to act in any such capacity, shall be guilty of the like offence unless he proves that the offence was committed without his knowledge or that he exercised all due diligence to prevent the commission of the offence.
