**Legal Service Division Report on  
Resolution under section 54 of the  
Matrimonial Causes Ordinance (Cap. 179)**

The Secretary for the Treasury has given notice to move a motion at the Legislative Council meeting on 29 November 2000 to seek the Legislative Council's approval of the Matrimonial Causes (Fees) (Amendment) Rules 2000 ("the Amendment Rules") made by the Chief Justice.

2. The Amendment Rules seek to increase with effect from 12 January 2001 the fees payable in connection with the services provided by the District Court in legal proceedings for matrimonial causes under the Matrimonial Causes Ordinance (Cap. 179). The proposed increases in the relevant fees are set out in the table below. The fees were last revised in 1994.

3. The Administration consulted the then LegCo Panel on Financial Affairs on the proposed revision of fees on 15 June 2000. A member of the Financial Affairs Panel expressed concern on the possible impact of the proposed fee increase on divorce applicants who had financial difficulty but were not eligible for legal aid. In reply, the Administration considered that the additional amounts as a result of the modest fee increase should be within the affordability of such applicants who were not eligible for legal aid. Members of the Panel raised no further queries on the proposed fee revision.

4. The legal and drafting aspects of the proposed resolution and the Amendment Rules are in order.
