**Report of Panel on Constitutional Affairs**

**Hong Kong Special Administrative Region Precedence Table**

**Purpose**

This paper reports on the deliberations of the Panel on Constitutional Affairs on the issue of the order of Legislative Council (LegCo) Members on the Hong Kong Special Administrative Region (HKSAR) Precedence Table.

**Background**

2. At the House Committee meeting on 8 December 2000, a Member raised concern about the precedence accorded to LegCo Members on the Precedence Table after 1 July 1997. He queried why Principal Officials and Directors of Bureaux should rank ahead of LegCo Members on the HKSAR Precedence Table. He was of the view that LegCo Members should rank immediately after Members of the Executive Council (ExCo), as in the case before 1 July 1997. The House Committee agreed that the matter should be followed up by the Panel on Constitutional Affairs.

**Deliberations of the Panel**

Overseas practices

3. In response to the request of the Panel, the Administration has looked into the order of precedence in the United States of America (USA), the United

Kingdom (UK) and the Republic of France. The Panel has noted that in the USA, Senators and Members of the House of Representatives rank immediately after cabinet members and other senior government officials. In the UK, Members of Parliament do not appear as a category on the precedence list. Their ranking is in practice judged on a case by case basis. In France, Members of the National Assembly and Senators rank after senior government members.

4. Members consider that it would not serve any meaningful purpose to make a direct comparison on the order of precedence between the HKSAR and overseas systems, given that the political structure and historical development of each country is different.

#### HKSAR Precedence Table

5. The Panel has noted that the major difference in the order of precedence accorded to LegCo Members prior to and after 1 July 1997 is as follows -

Pre-1997 - LegCo Members ranked 10<sup>th</sup>, before Justices of Appeal/Judges of the High Court and other Secretaries and Heads of Group I Departments who ranked 13<sup>th</sup> and 18<sup>th</sup> respectively.

Post-1997 - LegCo Members rank 9<sup>th</sup>, after Principal Officials/Directors of Bureaux, and Judges of the Court of Final Appeal (CFA)/Chief Judge of the High Court who rank 7<sup>th</sup> and 8<sup>th</sup> respectively.

Copies of the HKSAR Precedence Table and the former Hong Kong Precedence Table are at **Appendices I and II** respectively. A comparison of the two Precedence Tables is at **Appendix III**.

6. The Administration has explained that the post-1997 Precedence Table is

drawn up with reference to HKSAR's constitutional framework and also takes account of the status of certain categories of persons recognized by the Basic Law -

- (a) Principal Officials/Directors of Bureaux; and
- (b) Judges of CFA and the Chief Judge of the High Court of the HKSAR.

7. Members have the following observations and comments -

- (a) Prior to 1997, all judges except the Chief Justice, and Government officials except the Chief Secretary, the Financial Secretary and the Attorney General ranked after LegCo Members on the Precedence Table. After 1997, LegCo Members rank after Principal Officials/Directors of Bureaux as well as Judges of CFA and the Chief Judge of the High Court;
- (b) Prior to 1997, the President of LegCo ranked ahead of ExCo Members who were followed immediately by LegCo Members. After 1997, the President of LegCo ranks immediately after the Convenor of ExCo, and there are several categories of persons including ExCo Members, Principal Officials/Directors of Bureaux as well as judges of CFA and the Chief Judge of the High Court, between the President of LegCo and LegCo Members;
- (c) The argument that Principal Officials and Directors of Bureaux should be accorded higher precedence than LegCo Members in the HKSAR Precedence Table on the ground that their status is recognized by the Basic Law is not convincing, because the status of LegCo Members is also recognized by the Basic Law;
- (d) There should be no question of ExCo Members ranking ahead of

LegCo Members, given that the Basic Law makes no reference to individual ExCo Members. There is also no reason for the Convenor of ExCo, who has no substantive duties and functions, to be accorded higher precedence than the President of LegCo;

- (e) The fact that LegCo Members rank after Principal Officials/Directors of Bureaux would give an impression to overseas countries that LegCo Members have a lower status and are less important than Principal Officials/Directors of Bureaux in the political structure of Hong Kong; and
- (f) LegCo should be given a higher standing as its Members have the mandate of the people. The present arrangement reflects that the executive authorities pay no respect to LegCo.

8. The Administration has explained that the HKSAR Precedence Table is basically used as a guideline in organizing government and official functions, in particular in seating or receiving guests, and for facilitating business among governments. In drawing up the order of precedence for the HKSAR, the Administration has taken into consideration the changes in the political structure of Hong Kong in the years leading to July 1997. For instance, the Chief Secretary, the Financial Secretary and the Attorney General are no longer ex-officio Members of LegCo since 1995-96, and there is a new category of judges following the establishment of the Court of Final Appeal in 1997.

9. Despite the Administration's explanation, some members remain of the view that the Government has introduced a fundamental change to the order of precedence after 1 July 1997 which is unjustified. They urge the Chief Executive to reconsider the matter having regard to members' views. In response to the request of the Panel, the Administration has agreed to convey members' views to the Chief Executive.

10. On 10 April 2001, the Director of Administration advised in writing that the

views of members of the Panel have been duly conveyed to the Chief Executive.

**Advice Sought**

11. The House Committee is invited to note the deliberations of the Panel and the present position of the matter.
