

Legislative Council Panel on Financial Affairs Revision of Government Fees and Charges

PURPOSE

This paper seeks Members' views on proposals relating to the remaining Government fees and charges that are due for revision following the end of the moratorium.

BACKGROUND

2. Members may recall that the Financial Secretary froze most Government fees and charges in February 1998 to relieve and help Hong Kong ride out the financial storm. The moratorium was originally intended to last for one year but was further extended pending economic recovery.

3. In view of the continuing recovery of our economy, the Financial Secretary announced in the 2000-01 Budget Speech in March this year that we would be approaching Members to discuss how to deal with the revision of fees for different categories of public services. We first dealt with fees that do not have any direct impact on people's livelihood or general business activities. From April to June this year, we consulted the relevant LegCo panels to seek their views on our revision proposals for such fees. With the exception of a few items, Members raised no objection to our proposals and these are now gradually being implemented.

As regards the remaining Government fees and charges, the Financial Secretary announced last Monday (27 November) that we would not increase four major categories of livelihood-related fees - namely water tariffs, sewage charges, school fees and medical fees - until an appropriate later date. The first two categories of these fees are also business-related. The decision to extend the moratorium should help to contain business costs. We do not have a predetermined timeframe as to when we will resume revision of these fees. We will keep the matter constantly under review having regard to the economic situation of Hong Kong and the community at large. In due course, Bureau Secretaries will consult the relevant Panels in LegCo on the appropriate timing of the revision.

5. Financial Secretary's decision to freeze the four main categories of fees was made having regard to the fact that Hong Kong's economy is firmly on the road to recovery. We have now six consecutive quarters of positive GDP growth - the last three recording double digit growth. Our estimated GDP growth rate for the year as a whole has been adjusted upwards to 10%. Notwithstanding the economic recovery, we fully understand that many people are still suffering from the effects of the financial turmoil and the economic adjustments that have taken place over the past two years. This is particularly true for the lower- to middle-income employees who have not yet felt the full benefits of the recovery. Pay cuts or pay freezes which were imposed at the onset of the crisis remain in place for most of these employees.

6. In addition, as from 1 December, the Mandatory Provident Fund Scheme has come into force to provide the much-needed long-term financial security for employees. This scheme is the most important social policy we have implemented in recent years, representing the consensus of the community reached in the past discussions. It has far-reaching positive implications for the benefit of our workforce and for this reason it needs to begin as scheduled on 1 December. We cannot afford any last minute hold-up. We fully understand that some employees may require some time to adjust to the new arrangements in the introductory stage because of the need to contribute their share to the MPF scheme. We sympathise with these concerns and recognise the need to minimise the impact and, at the same time, ensure the smooth implementation of the scheme.

ADMINISTRATION'S POSITION AND PROPOSAL

7. We now need to consider those regulatory fees that have little impact on the daily life of general public or the running cost of business operators. We consider it fair to suitably adjust these fees to uphold the "user pays" principle.

The rationale of the "user pays" principle is to ensure that those who benefit from the services provided should pay for them, so that the costs of providing the services are fully or, where appropriate, partly recovered and do not fall on general taxpayers. The importance of the "user pays" principle is illustrated by the fact that income from fees and

charges is a major revenue source, accounting for 10% (\$15.5 billion) of total recurrent government revenue (\$153.3 billion) in the 2000-01 Estimates. It underpins our low tax policy and is an important tool in helping us to strive to achieve a fiscal balance as stipulated in the Basic Law. In the current financial year, the third year of the fee revision moratorium, taxpayers will subsidize users of Government services to the amount of \$2 billion. The longer we defer a fee revision of these fees with little impact on people's livelihood and general business activities, the greater the taxpayers will need to subsidize. This is not only unfair to the general taxpayers, but would also impose no financial discipline on the consumption of the resources involved. Ultimately it could increase the pressure for tax increases or introduction of new taxes.

Annex

9. Our intention is to revise the fees at the Annex very moderately. To facilitate Members' deliberation, we have categorised the fees into twelve groups and listed their existing fee levels, last revision date, target and existing cost recovery rates and estimated current annual revenue. Because of the moratorium, most of these fees have not been revised since 1996-97 at the latest. Furthermore, as a majority of these items will require legislative amendments before we can introduce the revised fees, the new fees will not come into effect until some time next year. Thus, by the time we resume revision of any of these fees, over four years would have elapsed.

10. We shall continue to exercise rigorous cost control to reduce the pressure for any fee increases. We will continue to proceed with our Enhanced Productivity Programme (EPP). Where appropriate, savings achieved from the EPP and other efficiency improvement measures have been factored into the calculation of the cost recovery rates for individual items in the Annex. In addition, bureaux and departments are conducting reviews to identify whether or not it is still necessary to provide the services covered by various fees and charges. Where a service (e.g. a licensing function) has become non-essential through the passage of time or other factors, we will take the necessary steps to dispense with its requirement and abolish the associated fee or charge. We aim to complete the reviews by the end of the current financial year.

MEMBERS' ADVICE

11. We should be grateful for Members' views on the list of fees proposed for revision as set out at the Annex, including the appropriate level of fee adjustment. If Members consider it necessary, the relevant bureaux will brief the relevant functional LegCo Panels on the concerned fee revision proposals.
