Urban Renewal

市區重建局條例草案於2000年6 月通過。在20年內,我們對舊市 區的理想是:

- 完成 200個優先重建項目
- 重建 1,400幢破舊失修的樓宇
- 安置 16,000個家庭
- 提供 50,000平方米休憩用地及 70,000平方米社區設施

The Urban Renewal Authority Bill was passed in June 2000. Our Vision for older built-up areas in 20 years' time:

- 200 priority projects completed
- 1,400 dilapidated buildings redeveloped
- 16,000 households rehoused
- 50,000m² of open space and 70,000m² of community facilities provided










