Electronic Payment of Fixed Penalty Ticket

INTRODUCTION

Under section 25 of the Fixed Penalty (Traffic Contraventions) Ordinance (Cap.237) and section 11 of the Fixed Penalty (Criminal Proceedings) Ordinance (Cap. 240), and section 28(1)(c) of the Interpretation and General Clauses Ordinance (Cap. 1), the Secretary for Transport is empowered to make and amend regulations to specify the persons to whom and the places at which a fixed penalty ticket (FPT) may be paid, and the manner of such payments.

2. In exercise of this power, the Secretary for Transport has made the Fixed Penalty (Traffic Contraventions)(Amendment) Regulation 2001 and the Fixed Penalty (Criminal Proceedings)(Amendment) Regulation 2001 at Annex A.

BACKGROUND AND ARGUMENT

3. Every year, some 1.5 million FPTs are issued under the Fixed Penalty (Traffic Contraventions) Ordinance and the Fixed Penalty (Criminal Proceedings) Ordinance. They can be paid either by post, or in person at counters of the Sub-Treasury Offices or Magistrates' courts or District Offices. At present, electronic payment option is not provided for the settlement of FPT.

4. Members of the public can use electronic payment methods (including Automatic Teller Machine (ATM), payment by phone and the Internet) to settle a wide range of Government bills such as taxes, rates and Government rents, water charges, repayments of student loans, etc. Given the success in launching electronic payment for other Government bills, and the significant number of FPT issued each year, the Administration considers it appropriate to provide electronic payment options for the settlement of FPT. This would provide more convenient payment channels to the public. Also, it

helps to achieve cost savings by reducing the demand for manned service counters.

5. It is Government's policy to promote the use of information technology. With the launch of the "Electronic Service Delivery" Scheme in 2000, the public are getting used to transact businesses with the Government on-line. In the context of the publication of the 2001 Digital 21 Information Technology Strategy in May 2001, the Information Technology and Broadcasting Bureau has promulgated a comprehensive E-Government strategy and has set the target to provide e-option for 90% of public services which are amenable to the electronic mode of delivery by end-2003. Providing an electronic payment option for FPT is in line with the E-Government strategy, and will contribute to the achievement of the overall E-Government target. Moreover, the Hongkong Post will launch a "PayThruPost" service for Government bills to take over the counter collection service currently provided by the Sub-Treasuries and certain District Offices. It is considered appropriate to extend the "PayThruPost" service to cover the settlement of FPT.

6. As the payment methods of FPTs are prescribed by legislation, amendments to the Fixed Penalty (Traffic Contraventions) Regulations and the Fixed Penalty (Criminal Proceedings) Regulations are required for the introduction of payment of FPTs by electronic means and through Hongkong Post's "PayThruPost" service.

AMENDMENT REGULATIONS

7. The purpose of the two Amendment Regulations is to provide electronic means and introduce Hongkong Post's "PayThruPost" service for the payment of FPT. The Amendment Regulations spell out in detail the method of FPT payments by electronic means and through Hongkong Post's "PayThruPost" service and their mode of operations.

BASIC LAW IMPLICATIONS

8. The Department of Justice advises that the Regulations are consistent with the Basic Law.

HUMAN RIGHTS IMPLICATIONS

9. The Department of Justice advises that the Regulations have no human right implications.

BINDING EFFECT

10. The amendments will not affect the current binding effect of the Fixed Penalty (Traffic Contraventions) Ordinance (Cap. 237) and the Fixed Penalty (Criminal Proceedings) Ordinance (Cap. 240).

FINANCIAL AND STAFFING IMPLICATIONS

11. The non-recurrent expenditure requirement for the enhancement of the backend computer system is \$0.66 million, which is funded under the Capital Work Reserve Fund (CWRF) Head 710 Computerization Subhead A007GX – New Administrative Computer Systems (Block Allocation). The recurrent expenditure requirement and staff effort will be met by existing resources. Based on an estimated 8% take-up of electronic payment in the initial stage of implementation, we estimated that there will be notional savings of about \$0.28 million per annum in the processing of FPT payment, and the savings are expected to increase over time with the increase in adoption of electronic payment in the community.

ECONOMIC IMPLICATIONS

12. The proposed legislative amendments to provide the electronic payment option for FPT payment will enable members of the public to make payments in a convenient and user-friendly manner on an “anywhere and anytime” basis. There will thus be savings in social costs, in terms of time saved for making FPT payment.

LEGISLATIVE TIMETABLE

13. The Amendment Regulations will come into effect on 1 November 2001.

PUBLIC CONSULTATION

14. The Administration consulted the Legislative Council Panel on Information Technology and Broadcasting on the E-Government strategy on 28 May 2001. The Panel noted that the Administration's target is to provide e-option for more public services with a view to achieving the over E-Government target.

PUBLICITY

15. The Amendment Regulations will be gazetted on 6 July 2001.

1. Commencement

This Regulation shall come into operation on 1 November 2001.

2. Payment of fixed penalty

Regulation 3 of the Fixed Penalty (Traffic Contraventions) Regulations (Cap. 237 sub. leg.) is amended -

(a) in paragraph (1) -

(i) by repealing subparagraph (a) and substituting -

"(a) by post addressed to the Treasury, P.O.
Box No. 28000, Gloucester Road Post
Office, Hong Kong;"

(ii) in subparagraph (b) -

(A) by repealing sub-subparagraph (i) and
substituting -

- (i) at any Post Office other than a post office letter box or a mobile post office; or";
- (B) in sub-subparagraph (ii), by repealing "or";
- (C) by repealing sub-subparagraph (iii);
- (iii) by adding -
 - (c) through any automated teller machine of a bank;
 - (d) by phone by using the service commonly known as the Payment By Phone Service; or
 - (e) through the Internet.";
- (b) in paragraph (2) -
 - (i) by repealing "(1)" and substituting "(1)(a) or (b)";
 - (ii) by adding "in accordance with the payment instructions as set out in the notice" before the full stop;
- (c) in paragraph (6), by adding "in accordance with paragraph (1)(b)" after "penalty".
