### **INTRODUCTION**

At the meeting of the Executive Council on 7 November 2000, the Council ADVISED and the Chief Executive ORDERED that -

- (a) the Waste Disposal (Permits and Licences) (Forms and Fees) (Amendment) Regulation 2000, at Annex A, and the Waste Disposal (Chemical Waste) (General) (Amendment) Regulation 2000, at Annex B should be made under section 33 of the Waste Disposal Ordinance (WDO) (Chapter 354); and
- (b) the Water Pollution Control (General) (Amendment) Regulation 2000, at Annex C should be made under section 46 of the Water Pollution Control Ordinance (WPCO) (Chapter 358).

### **BACKGROUND AND ARGUMENT**

#### **Fees and charges revision**

2. It is Government policy that fees should in general be set at levels sufficient to recover the full cost of providing the services. Most Government fees and charges have been frozen since February 1998 as an exceptional measure to ease the burden on the community at a time of economic setback. The Financial Secretary decided in June 1999 to continue the fee revision moratorium until the year-on-year quarterly Gross Domestic Product growth rate turned firmly positive. In view of the current state of economic recovery, the Administration consulted the Legislative Council Panel on Financial Affairs on 13 April 2000 on proposals to revise various fees that would not directly affect people's livelihood or general business activities. In view of the diverse nature of the fees involved, members suggested and the

Legislative Council House Committee agreed on 14 April 2000 that the Administration should consult the relevant subject Legislative Council Panels on whether and if so how the fees under their respective purview should be adjusted.

3. In this connection, we consulted the Legislative Council Panel on Environmental Affairs on 2 June 2000 on the proposal to revise the fees under the WDO and the WPCO. Members of the Panel did not raise any objection to the proposed fee revision. The existing and proposed fees are summarized at Annex D.

### **Fee items under the WDO**

4. The existing fees under the WDO were last revised in January 1998. A recent costing review conducted at 2000-01 prices shows that fourteen fees require adjustment. They cover application and renewal of waste collection and disposal licences, and permits for import and export of waste under Schedule 2 to the Waste Disposal (Permits and Licences) (Forms and Fees) Regulation; and registration as a waste producer and issue of a certified copy of an entry in the register under section 7(5) of the Waste Disposal (Chemical Waste) (General) Regulation. To achieve full-cost recovery of the services at 2000-01 prices, we propose to adjust three fees upward by 1% and adjust the other eleven fees downward by 1% to 64%. The cost computations are set out at Annexes E and F.

### **Fee items under the WPCO**

5. The licence fees were last revised in January 1998 in accordance with a phasing-in programme based on the increase in cost recovery rate aiming at achieving full cost recovery between 1999/00 and 2004/05. However, the licence fees for discharge or deposit from domestic premises and discharge or deposit from industrial, institutional or commercial premises of domestic sewage are classified as “subsidized fees” which are set at 20% of the cost. We propose the following adjustments:

- The licence fees for discharge or deposit from domestic premises and for discharge or deposit from industrial, institutional or commercial premises of domestic sewage will be maintained at subsidized levels and will be decreased by 64% due to cost savings brought about by extensive computerisation in the licence application process.
- The licence fees for discharge or deposit from certain industrial, institutional or commercial premises –
  - (a) for discharges of low flow rate - will be increased by 10% to 15% with full cost recovery phased in over 3 years;
  - (b) for discharges of medium flow rate - will be increased by 5% and full cost recovery phased in over 2 years (for new applications) or decreased by 9% (renewal applications) based on the full cost at 2000/01 prices; and

(c) for discharges of high flow rate - decreased by 40% to 44% based on the full cost at 2000/01 prices. (Again, this is due to cost savings brought about by extensive computerisation in the licence application process.)

- The licence fees for discharge or deposit from domestic sewage treatment plants will be decreased by 26% to 32% based on the full cost at 2000/01 prices.

The cost computations are at Annex G.

## **THE REGULATIONS**

6. The Amendment Regulations are at Annexes A to C. The major provisions are as follows –

- (a) Waste Disposal (Permits and Licences) (Forms and Fees) (Amendment) Regulation 2000  
Section 2 revises the fees payable for permits and licences for the import, export, collection and disposal of waste.
- (b) Waste Disposal (Chemical Waste) (General) (Amendment) Regulation 2000  
Section 2 decreases the fees for registration of a waste producer and for a certified copy of an entry in the register.
- (c) Water Pollution Control (General) (Amendment) Regulation 2000  
Section 2 revises the fees payable in relation to the matters mentioned in the Third Schedule to the Water Pollution Control (General) Regulations (Cap. 358 sub. leg.).

## **LEGISLATIVE TIMETABLE**

## **BASIC LAW IMPLICATIONS**

8. The Department of Justice advises that the Amendment Regulations are consistent with the Basic Law.

## **HUMAN RIGHTS IMPLICATIONS**

9. The Department of Justice advises that the Amendment Regulations have no human rights implications.

## **BINDING EFFECT OF THE LEGISLATION**

10. The amendments will not affect the current binding effect of the Ordinances.

## **FINANCIAL AND STAFFING IMPLICATIONS**

11. The implementation of the new fees will reduce Government revenue by about \$156,000 per annum. There are no staffing implications.

## **ECONOMIC IMPLICATIONS**

12. Those items with proposed fee increases should carry little cost impact on the businesses concerned. For those items with proposed fee reduction, the existing cost impact, whatever the magnitude is, would be reduced.

## **EFFICIENCY INITIATIVES**

13. To provide a more efficient service to the public, the Environmental Protection Department (EPD) has already implemented efficiency improvement measures over the past years. For this reason, many of the fee items can now be adjusted downward. The department will continue to undertake necessary measures to -

- (a) contain costs by continuing to implement the Enhanced Productivity Programme and taking other productivity improvement measures; and
- (b) review whether it is still necessary to provide the various services that require payment of fees and charges.

## **ENVIRONMENTAL IMPLICATIONS**

14. The recovery of costs is consistent with the "polluter pays" principle. There are no environmental implications.

## **PUBLIC CONSULTATION**

15. The Legislative Council Panel on Environmental Affairs was consulted on 2 June 2000. Members did not raise any objection to the proposed fee revision. The Advisory Council on the Environment was consulted on 30 October 2000. Members have no objection to the proposals.

## **PUBLICITY**

16. A press release will be issued on 8 November 2000. A spokesman will be made available to answer media enquiries.
