Declaration of Change of Titles (Senior Management Personnel of Civil Aviation Department) Notice 2000

(Made under section 55 of the Interpretation and General Clauses Ordinance (Cap. 1))

1. Commencement

This Notice shall come into operation on 1 January 2001.

2. Change of titles

(1) The title of the Director of Civil Aviation is declared to be changed to the Director-General of Civil Aviation.

(2) The title of the Deputy Director of Civil Aviation is declared to be changed to the Deputy Director-General of Civil Aviation.

(3) The title of the Assistant Director of Civil Aviation (Flight Standards) is declared to be changed to the Assistant Director-General of Civil Aviation (Flight Standards).

(4) The title of the Assistant Director of Civil Aviation (Airport Standards) is declared to be changed to the Assistant Director-General of Civil Aviation (Airport Standards).

(5) The title of the Assistant Director of Civil Aviation (Air Services) is declared to be changed to the Assistant Director-General of Civil Aviation (Air Services).

(6) The title of the Assistant Director of Civil Aviation (Technical and Planning) is declared to be changed to the Assistant Director-General of Civil Aviation (Engineering and Systems).

(7) The title of the Air Traffic General Manager is declared to be changed to the Assistant Director-General of Civil Aviation (Air Traffic Management).

(8) The title of the Deputy Air Traffic General Manager (ATS Procedures and Personnel Management) is declared to be changed to the Chief Air Traffic Control Officer (ATS Procedures and Personnel Management).

(9) The title of the Deputy Air Traffic General Manager (PANSOPS, Systems and Standards) is declared to be changed to the Chief Air Traffic Control Officer (PANSOPS, Systems and Standards).

(10) The title of the Deputy Air Traffic General Manager (Training and Evaluation) is declared to be changed to the Chief Air Traffic Control Officer (Training and Evaluation).

(11) The title of the Deputy Air Traffic General Manager (Project and

Development) is declared to be changed to the Chief Air Traffic Control Officer (Project and Development).

3. Amendment of references to titles

(1) The enactments specified in column 2 of Part I of Schedule 1 are amended by substituting "Director-General of Civil Aviation" for "Director of Civil Aviation" wherever occurring in the provisions specified opposite to them in column 3.

(2) The enactment specified in column 2 of Part II of Schedule 1 is amended by substituting "Director-General of Civil Aviation" for "Director of Civil Aviation" occurring in the provision specified opposite to it in column 3.

(3) The enactments specified in column 2 of Schedule 2 are amended by substituting "Deputy Director-General of Civil Aviation" for "Deputy Director of Civil Aviation" wherever occurring in the provisions specified opposite to them in column 3.

(4) The enactments specified in column 2 of Schedule 3 are amended by substituting "Assistant Director-General of Civil Aviation" for "Assistant Director of Civil Aviation" wherever occurring in the provisions specified opposite to them in column 3.

(5) The enactment specified in column 2 of Schedule 4 is amended by substituting "Assistant Director-General of Civil Aviation (Air Traffic Management)" for "Air Traffic General Manager" occurring in the provision specified opposite to it in column 3.

The titles specified in column 3 of Schedule 5 are substituted for those specified opposite to them in column 2 wherever occurring in any instruments, contracts or legal proceedings made or commenced before 1 January 2001.
