2001; and
- (b) the Poisons List (Amendment) (No. 2) Regulation 2001.

**PHARMACY AND POISONS (AMENDMENT) (NO. 3) REGULATION 2001**

(Made by the Pharmacy and Poisons Board under section 29  
of the Pharmacy and Poisons Ordinance (Cap. 138)  
subject to the approval of the  
Legislative Council)

**1. Substances falling within the Poisons List  
to which special restrictions apply under  
regulations 3 and 5**

The First Schedule to the Pharmacy and Poisons Regulations (Cap.  
138 sub. leg.) is amended in part A -

(a) in the item beginning from "Contrast media, the  
following; their salts;" and ending at "Tyropanoic  
acid", by adding "Gadobenic acid" under "Diatrizoic  
acid";

(b) by adding -

"Becaplermin; its salts

Esomeprazole; its salts

Linezolid; its salts

Pioglitazone; its salts

Verteporfin; its salts".

**2. Substances required by regulation 9 to be  
sold by retail only upon a prescription  
given by a registered medical  
practitioner, registered  
dentist or registered  
veterinary surgeon**

The Third Schedule is amended in part A -

(a) in the item beginning from "Contrast media, the

following; their salts;" and ending at "Tyropanoic acid", by adding "Gadobenic acid" under "Diatrizoic acid";

(b) by adding -

"Becaplermin; its salts

Esomeprazole; its salts

Linezolid; its salts

Pioglitazone; its salts

Verteporfin; its salts".
