In 2001-02, the consultancy study commissioned by the Police Force has looked into the following areas providing expertise, advice and support to the Force:

Items	Objectives
Force management	To conduct environmental studies, and to assess and consolidate matters that have impact on the Strategic Directions with a view to setting future operations and management priorities.
Performance assessment	To formulate, implement and follow up key performance yardsticks; to put into practice the Vision and Mission of the Force; and to improve performance review in order to monitor the standard of service and to strive for excellence.
Division management	To analyse the work of divisions, to formulate a mechanism for planning and target setting, to enhance programme management, and to provide guidelines and directions on operations and priority management.
Internal communications	To formulate and implement an action plan for the Force strategy on internal communication Force-wide to facilitate promotion and improvement of service culture, attitude to work and application of technology for effective internal communication.

The above advising and supporting services provided by the consultant in 2001-02 will continue in 2002-03. Attention will be focused on the consolidation of the operational and management priorities for the Force, programme management of divisional actions, the review of performance and promotion of the most effective operational methods.

Eight police officers were promoted in 2000 and four in 2001 after the Independent Police Complaints Council reviewed and found that complaints against them were substantiated. Please separate out the police officers concerned according to rank (inspector or above and junior police officers). Also, please give the number of police officers who were disciplined after the complaints against them were found substantiated.

Reply:

One chief inspector and seven junior police officers were promoted in 2000 after the Independent Police Complaints Council reviewed and found that complaints against them were substantiated. Among them, one of the junior police officers was recommended for promotion in 1998-99. However, as the case against him had yet to be concluded, his promotion was put on hold. His case was concluded in 2000 and he was awarded the punishment of 'reprimand' as a result of the disciplinary proceedings instituted against him. According to the Police General Orders, those police officers awarded the punishment of 'reprimand' normally will not be promoted within 12 months. Since this police officer's promotion had already been put on hold for two years because of his case, he was subsequently promoted in accordance with the principle of fairness. For the other officers, they had been given verbal or written advice. Verbal advice or written advice is not disciplinary punishments that affect promotion. Under the principle of fairness, such punishments do not bar the officers concerned from being promoted.

Four junior police officers were promoted in 2001 after the Independent Police Complaints Council reviewed and found that complaints against them were substantiated. Verbal or written advice was given to these four junior police officers.

Reply:

As I have told in the Special Finance Committee Meetings, many cities have not conducted similar surveys. For those who have, they had target population and objectives different from ours and so the design of questions and the methodology employed were different. Because of the time constraint, we can only locate four such surveys. Two of them did not distinguish between the law and order situation at daytime and night time and as a result it is difficult to make comparison. The figures for the other two surveys are:

Reply :

The number of employers arrested for employing foreign domestic helpers illegally stood at 209 in 2000 and 259 in 2001. In 2002 (January – February), the number is 38.

The number of employers arrested in 2001 is greater than the number of foreign domestic helpers arrested because in some cases:

- (a) the illegal deployment of foreign domestic helpers amongst non-contractual parties involved more than one employer;
- (b) the interception of foreign domestic helpers engaged in illegal employment led to further investigations into the helpers' previous illegal employment in some other workplaces and thence more than one employer was involved; and
- (c) the employment process of foreign domestic helpers in some business establishments involved more than one person.

Reply :

The number of applications for Certificates of Entitlement carried forward from 1999 to 2000 is 23 191 and the number of applications carried forward from 2000 to 2001 is 10 906.

It was estimated that about 17 000 new applications would be received in 2002. The figure was based on the number of new applications received in 2001, plus a certain percentage increase arising from those requiring DNA test.

Question(s) :

- (a) The Director, Mr. Bowen Leung, mentioned that a fund had already been set up by the Beijing Office to provide assistance to Hong Kong residents in distress in the Mainland. When was the fund set up, how much money did the fund have at the outset and how much of the fund is still available for use?
- (b) How many times has the fund been used to help Hong Kong residents in distress in the Mainland and how much money was allocated in each case? Please provide a breakdown of fund usage by the types of assistance provided.
- (c) What are the eligibility criteria and application procedures of the fund? How long does it take to approve an application?

Asked by : Hon. LEE Chu-ming, Martin

Reply:

- (a) To offer assistance to Hong Kong residents who are in distress in the Mainland, the Beijing Office set up an advance account (i.e. the 'fund' raised in the question) in March 2001. The prime purpose of the account is to provide recoverable

emergency financial assistance to Hong Kong residents who are in distress in the Mainland but are unable to seek any assistance from friends or relatives so that basic and necessary payments can be met. The amount reserved was RMB¥13,000 at the time the advance account was set up, but will be adjusted when necessary.

(b) We announced the setting-up of the advance account on 31 March 2001. As at the end of December 2001, no request for assistance that requires provision from the advance account has been received.

(c) The eligibility criteria and application procedures of the fund as well as the time required for the approval of applications are as follows:

(1) Eligibility Criteria

To be eligible for an advance, the assistance-seeker must be a Hong Kong resident who has exhausted all possible means but fails to obtain financial assistance from his relatives or friends in Hong Kong. The assistance-seeker is required to sign an undertaking to the effect that he will return to Hong Kong once the matter is settled and will repay the full amount of the advance upon his return to Hong Kong.

(2) Application Procedures

When the assistance-seeker applies for an advance, the Office will verify his eligibility, identity and repayment ability. If the application is approved, the Office will also explain to him the terms and requirements of the advance. After the undertaking of repayment is signed, the necessary advance will be issued by the Office.

(3) Approval Time

The Office will endeavour to process the applications as soon as possible subject to the circumstances of individual cases.

Question : What are the details of the funding arrangement and the plan regarding the production of a public educational video programme and a web page by the Hong Kong Observatory in 2002/03 on the emergency preparedness of Hong Kong in the event of a nuclear accident?

Reply:

The Hong Kong Observatory will produce a video and a webpage to promote public awareness and understanding of the "Hong Kong Special Administrative Region Daya Bay Contingency Plan" in 2002. Production of the video and the webpage is estimated to cost around HK\$300,000 each. Funds will be made available through deployment of existing resources of the Security Bureau.

The video and webpage will cover the concept of nuclear emergency planning, radiation monitoring and assessment activities in Hong Kong, and the contingency plan during nuclear emergencies including Government's measures, information dissemination arrangements and advice to the public. After launch, the webpage can be accessed by the public at any time through the Internet and will be updated as required. The video will be distributed to schools and the general public via the Education Department and the Home Affairs Department. It will also contribute to the contents of the webpage.
