INTERPRETATION AND GENERAL CLAUSES ORDINANCE

RESOLUTION

(Under section 54A of the Interpretation and General Clauses Ordinance (Cap. 1))

RESOLVED that with effect from 1 July 2002 –

- (1) the functions exercisable by the Secretary for Constitutional Affairs by virtue of the Ordinances specified in column 2 of Schedule 1 be transferred to the Chief Secretary for Administration, as provided for by the amendments made under paragraph (2);
- (2) for the purpose of giving full effect to paragraph (1), the provisions specified in Schedule 1 be amended by repealing “Secretary for Constitutional Affairs” and substituting “Chief Secretary for Administration”.
