I Election of Chairman

Mr SIN Chung-kai accepted the nomination. There being no other nomination, Mr SIN Chung-kai was elected as Chairman of the Bills Committee.

II Any other business

Invitation for written views and meeting with deputations

3. The Bills Committee agreed to invite written views on the Bill from the following organizations:

- (a) those which the Administration had invited views from on the proposal to liberalize parallel importation of computer software in May 2001 (Appendix II to of LC Paper No. CB(1) 2237/01-02(01));
- (b) those which had been invited by the Panel on Commerce and Industry for views on the Government's consultation document on "Review of Certain Provisions of Copyright Ordinance" at its special meeting held on 10 January 2002; and
- (c) Oxfam Hong Kong.

4. Members also agreed to invite views from District Councils and place a notice on the website of the Legislative Council to invite views from the public.
