I. Confirmation of minutes of meeting

(LC Paper No. CB(2) 2777/01-02)

The minutes of the meeting on 17 July 2002 were confirmed.

II. Meeting with deputations and the Administration

(LC Papers Nos. CB(2) 2775/01-02(01) - (21))

- 2. The Bills Committee met with representatives of the deputations and the Administration. Representatives from nine organisations and four individuals gave oral representations to the Bills Committee. The Bills Committee deliberated (index of proceedings attached at **Annex**).
- 3. The Bills Committee noted that 20 submissions had been received from 19 organisations/individuals (one organisation provided two submissions). Of these, eleven organisations/individuals expressed support for raising the minimum age of criminal responsibility to ten, and seven organisations/individuals were in favour of raising the age of criminal responsibility to 14 years. The Hong Kong Bar Association proposed to raise the minimum age of criminal responsibility to 12 years, while the Law Society of Hong Kong would submit its views on the Bill after a meeting on 24 September 2002.
- 4. The Bills Committee also noted that for those who supported raising the minimum age of criminal responsibility to ten years, they all supported retaining the rebuttable common law presumption of doli incapax for children between the revised minimum age of ten and below 14.
- 5. At the request of the Chairman, some deputations gave further views on the proposals of raising the age of criminal responsibility to 12 years or 14 years. While most deputations had no objection to further raising the age of criminal responsibility to 12 or 14, some expressed concern about the availability of appropriate services to juvenile offenders who were not arrested or prosecuted. Some deputations and members also raised concern about the exploitation of children by adults in criminal activities, and the system for determining what services should be provided to the juvenile offenders.
- 6. In response to the concerns raised by deputations and members, the Chairman requested the Administration to provide further information on the following -
 - (a) whether the Administration anticipated any problems (e.g. adequacy of services to juvenile offenders) if the minimum age of criminal responsibility was raised to 12 or 14 years; and
 - (b) any change in the crime rate in overseas jurisdictions after raising their minimum age of criminal responsibility.

III. Date of the next meeting

- 7. The Bills Committee agreed to hold the next meeting in October 2002 to further consider whether amendments should be made to the Bill in respect of the minimum age of criminal responsibility. The Clerk would issue a circular to inform members of the date of the next meeting.
- 8. There being no other business, the meeting ended at 10:45 am.
