**I Confirmation of minutes of meeting**  
[LC Paper No. CB(2) 312/02-03]

The minutes of the meeting on 23 October 2002 were confirmed.

**II Meeting with the Administration**  
[LC Paper No. CB(2) 310/02-03(01)]  
[Annex C to LC Paper No. CB(1) 185/02-03(04)]

2. The Bills Committee deliberated (Index of proceedings attached at **Annex**).
3. Members expressed concern whether there would be safeguards in the computer program to enable taxpayers to rectify any inadvertent mistakes made in the process of filing a tax return, as the taxpayer would be criminally liable for the filing of inaccurate tax return.
4. Some members also pointed out that professional bodies had expressed concern about the drafting of certain clauses in the Bill, e.g. the definition of "password" and the reference to "password is to be affixed to a return". The Chairman requested the Administration to address these concerns and the other drafting points raised by the deputations and in the written submissions received.

5. The Bills Committee requested the Administration to -
- (a) consider to provide in the Bill or in a code of practice, how "reasonable excuse" may be used as a defence to the filing of an incorrect tax return using a password;
  - (b) provide the draft Committee Stage amendments to the Bill taking into account the views of members and in the submissions;
  - (c) highlight in its publicity programme the difference between using Personal Identification Number (PIN) and digital signature in filing tax returns and their corresponding security levels; and
  - (d) arrange a demonstration on electronic filing of tax return through the Electronic Service Delivery Scheme and the Telefiling System with the use of a password.

### **III. Date of next meeting**

6. The Bills Committee agreed to hold the next meeting in 13 December 2002 at 8:30 am to continue discussion with the Administration and to start clause-by-clause examination of the Bill.
7. There being no other business, the meeting ended at 9:50 am.
