Two Members spoke on the Bill.

The Secretary for Transport replied.

Question on the Second Reading put and agreed to.

Bill read the second time and committed to a Committee of the whole Council.

Five Members and the Secretary for Transport spoke on the amendment.

Hon Andrew CHENG spoke again.

Two Members who had spoken and the Secretary for Transport spoke again on the amendment.

Another Member, who had spoken, spoke again on the amendment.

Question on the amendment put.

Hon Andrew CHENG claimed a division. The Chairman then ordered the Committee to divide under Rule 47(1) of the Rules of Procedure.

The Chairman announced that among the Members returned by functional constituencies, 29 were present, four were in favour of the amendment, 23 against it and two abstained; while among the Members returned by geographical constituencies through direct elections and by the Election Committee, 25 were present, 13 were in favour of the amendment and 11 against it. (Voting record in Appendix I.) Since the question was not agreed by a majority of each of the two groups of Members present, she declared that the amendment was negatived.

Hon Andrew CHENG moved an amendment to add sub-clause (1A) to clause 6 and addressed the Committee.

The Secretary for Transport spoke on the amendment.

Question on the amendment put.

Hon Andrew CHENG claimed a division. The Chairman then ordered the Committee to divide under Rule 47(1) of the Rules of Procedure.

The Chairman announced that among the Members returned by functional constituencies, 29 were present, five were in favour of the amendment, 23 against it and one abstained; while among the Members returned by geographical constituencies through direct elections and by the Election Committee, 25 were present, 13 were in favour of the amendment and 11 against it. (Voting record in Appendix II.) Since the question was not agreed by a majority of each of the two groups of Members present, she declared that the amendment was negatived.

**Members' Motions**

**Proposed resolution under the Interpretation and General Clauses Ordinance**

Hon Kenneth TING moved the following motion and addressed the Council:

Resolved that in relation to the -

- (a) Dutiable Commodities (Amendment) Regulation 2001, published in the Gazette as Legal Notice No. 248 of 2001 and laid on the table of the Legislative Council on 28 November 2001;
- (b) Dutiable Commodities (Amendment) Ordinance 2001 (19 of 2001) (Commencement) Notice 2001, published in the Gazette as Legal Notice No. 255 of 2001 and laid on the table of the Legislative Council on 5 December 2001; and
- (c) Dutiable Commodities (Amendment) Regulation 2001 (L.N. 248 of 2001) (Commencement) Notice 2001, published in the Gazette as Legal Notice No. 256 of 2001 and laid on the table of the Legislative Council on 5 December 2001,

the period referred to in section 34(2) of the Interpretation and General Clauses Ordinance (Cap. 1) for amending subsidiary legislation be extended under section 34(4) of that Ordinance to the meeting of 9 January 2002.

Question on the motion proposed, put and agreed to.

**Strengthening co-operation with Guangdong in developing the logistics industry**

Hon HUI Cheung-ching moved the following motion and addressed the Council:

That, as both Hong Kong and Guangdong have been vigorously developing the logistics industry in recent years but have rarely engaged in co-operative projects, in order to avoid harmful competition, this Council urges the Government to:

- (a) apart from studying the co-development of Nansha, explore more options with the Guangdong Provincial Government for strengthening co-operation and the streamlining of the logistics industry and co-ordinating more effectively the development objectives and strategies in both places;
- (b) as far as possible, accord priority in allocating resources for cross-boundary sea, land and air transport infrastructural projects and expeditiously remove the



barriers hindering the operation of the logistics businesses in both places, including implementing round-the-clock cargo clearance for laden goods vehicles in other border control points, actively studying the construction of a bridge connecting Hong Kong, Macau and Zhuhai, granting traffic rights for air cargo services as appropriate, implementing the streaming and connection of flight routes with the airports in the Pearl River Delta, and establishing a technology platform whereby Hong Kong and Guangdong can exchange logistics information; and

- (c) encourage enterprises in Hong Kong and Guangdong to invest in each other's logistics industry and infrastructural services relating to sea, land and air transport.

While Hon HUI Cheung-ching was addressing the Council, the President left the chair at 7:55 pm temporarily and the President's Deputy, Hon Mrs Selina CHOW, took the chair.

Question on Hon HUI Cheung-ching's motion proposed.

The President's Deputy stated that Hon SIN Chung-kai would move an amendment to the motion. In accordance with the Rules of Procedure, the motion and the amendment would be debated together in a joint debate.

Hon SIN Chung-kai moved the following amendment to Hon HUI Cheung-ching's motion and addressed the Council:

To delete "apart from studying the co-development of Nansha," after "(a)" and substitute with "comprehensively"; and to delete "more" after "explore" and substitute with "various feasible".

Question on Hon SIN Chung-kai's amendment to Hon HUI Cheung-ching's motion proposed.

12 Members spoke on the motion and the amendment.

Hon HUI Cheung-ching spoke on the amendment.

The Secretary for Economic Services spoke on the motion and the amendment.

At 9:22 pm, while the Secretary for Economic Services was speaking, the President resumed the chair.

Question on Hon SIN Chung-kai's amendment to Hon HUI Cheung-ching's motion put.

Hon SIN Chung-kai claimed a division. The President then ordered the Council to divide under Rule 47(1) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 23 were present, 15 were in favour of the amendment and eight against it; while among the Members returned by geographical constituencies through direct elections and by the Election Committee, 23 were present, 14 were in favour of the amendment and eight against it. (Voting record in the Appendix III.) Since the question was agreed by a majority of each of the two groups of Members present, she declared that the amendment was agreed.

Hon HUI Cheung-ching replied.

Question on Hon HUI Cheung-ching's motion as amended by Hon SIN Chung-kai put and agreed to.

### Opposing unfair competition

Hon LEUNG Yiu-chung moved the following motion and addressed the Council:

That, as currently unreasonable market domination and unfair competition exist in such domains as power supply, gas, petroleum products, supermarkets, container terminals and their complementary services, and the Easy Pay System, and the trend tends to escalate, thereby adversely affecting people's livelihood as well as industrial and commercial enterprises, this Council urges the Government to expeditiously enact a fair competition law and set up a fair competition authority, so as to promote fair competition and safeguard the rights and interests of the public.

Question on the motion proposed.

15 Members and the Secretary for Economic Services spoke on the motion.

Hon LEUNG Yiu-chung replied.

Question on the motion put.

Hon LEUNG Yiu-chung claimed a division. The President then ordered the Council to divide under Rule 47(1) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 23 were present, five were in favour of the motion, 17 against it and one abstained; while among the Members returned by geographical constituencies through direct elections and by the Election Committee, 22 were present, 12 were in favour of the motion and nine against it. (Voting record in Appendix IV.) Since the question was not

agreed by a majority of each of the two groups of Members present, she declared that the motion was negatived.

**Next Meeting**
