Question : The provision for the Commerce and Industry Bureau for 2002-03 will be reduced by 12.7% in 2002-2003. Instead of deleting permanent posts, why will there be one additional permanent post?

Asked by : Hon. HUI Cheung-ching

Reply :

The provision for 2002-03 is 12.7% lower than the revised estimate for 2001-02. This is mainly due to the full-year savings of short-term posts deleted in 2001-02, the reduced requirement for capital expenditure in 2002-03 and reduced operating expenses under the Enhanced Productivity Programme (EPP) in 2002-03. In relation to deletion of posts, apart from deleting the short-term posts created for the organisation of the 14th General Meeting of the Pacific Economic Cooperation Council and related meetings held in Hong Kong in end 2001, we will also delete 3 posts as a result of rationalising the secretarial and clerical services under EPP.

For 2002-03, we need to create 1 post to strengthen administrative support to cope with the operational requirements.

Question : The expenditure for 2002-03 was reduced by 12.7% as a result of the reduction of capital expenditure, the deletion of posts and the implementation of the Enhanced Productivity Programme in the previous year. What is the objective for the current year?

Asked by : Hon. CHAN Kam-lam

Reply :

The provision for 2002-03 is \$16.4 million (12.7%) lower than the revised estimate for 2001-02. This is mainly due to the full-year savings of short-term posts deleted in 2001-02, the reduced requirement for capital expenditure in 2002-03 and reduced operating expenses under the Enhanced Productivity Programme (EPP) in 2002-03.

For 2002-03, our target for savings will be based on EPP which amounts to \$1.99 million. The EPP measures largely involve rationalising the executive support as well as the provision of secretarial and clerical services. Other EPP measures include economising on the departmental operating expenses and the wider use of e-mail in internal and external communication to reduce expenditure on postage, long distance telephone calls/facsimile transmission, photocopying, paper etc.

- (a) The Commerce and Industry Bureau will participate in consultations with the Mainland on the establishment of the “Mainland/Hong Kong Closer Economic Partnership Arrangement”. Please specify the grades and ranks of the participating officers. What are their major areas of work? What is the expenditure involved?
- (b) What is the number of staff responsible for monitoring and reviewing the progress in implementing the new support measures for small and medium enterprises? What is the expenditure required?

Asked by: Hon. HUI Cheung-ching

Reply:

- (a) On the consultation mechanism for the Mainland/Hong Kong Closer Economic Partnership Arrangement (CEPA), the Financial Secretary, assisted by the Secretary for Commerce and Industry, heads a special taskforce on the HKSAR side. The special taskforce comprises officials from the Commerce and Industry Bureau, Trade and Industry Department, and other relevant Policy Bureaux and Departments. In addition, the technical aspects of the consultations are being tackled at the Senior Officials level.

As far as the Commerce and Industry Bureau is concerned, the Secretary for Commerce and Industry and his officials, irrespective of ranks and grades, are actively participating and supporting the consultations and related work. Financial and staffing implications arising from this work program have been absorbed through flexible redeployment of the Bureau's existing resources, without involving additional resources or creating permanent posts. At the working level, the Principal Assistant Secretary (1), assisted by Principal Trade Officer (1) and an

Assistant Secretary, is responsible for the daily coordination work. Since the CEPA consultations involve many different sectors, the Trade and Industry Department and relevant Policy Bureaux and Departments also actively participate in and provide assistance to the consultations. Hence, it is impossible to quantify the expenditure involved.

The CEPA consultations focus on trade in goods, trade in services, as well as trade and investment facilitation. Separately, the Government is conducting an extensive consultation with respective business sectors, commerce and industrial organizations as well as professional bodies on the content of the CEPA.

Reply:

Over 15 studies and projects were completed in 2001-02 under the Helping Business Programme. Almost all the improvement recommendations and initiatives have been accepted by the government bureaux and departments concerned. They are being actively pursued by these bureaux and departments which have plans for phased implementation. Up to now more than 20 measures have been implemented.

Of the above studies and projects, six require hiring of consultancy services with a total cost of \$9,209,000. There are eight full time staff in Commerce and Industry Bureau responsible for promoting the Helping Business Programme. Total staff emolument in 2001-02 for these staff is \$5,524,000. Since the staff are frequently engaged in different studies/projects at the same time, it is not possible to relate the staff expenditure to individual studies and projects.

Apart from that, staff from the bureaux and departments concerned also take part in the above-mentioned studies/projects. We have not calculated in fiscal terms their related expenditure for the Helping Business Programme.

In 2002-03, the Commerce and Industry Bureau has earmarked \$5,524,000 for the Personal Emolument in respect of these staff and included an estimate of \$11,600,000 for employing consultants to conduct the following studies under the Programme -

Reply:

The progress of the three items in question and the related plans for the coming year are detailed as follows:

- (1) *Continue to identify and implement appropriate initiatives to promote the service industries*

The Services Promotion Strategy Group, chaired by the Financial Secretary, formulates an Action Agenda each year to set out initiatives which help promote the development of the service industries. The Group also co-ordinates follow-up actions by relevant departments arising from the Action Agenda. The Action Agenda for this year includes 10 items. For details, please refer to Annex A.

In addition, the Business and Services Promotion Unit (BSPU) of the Commerce and Industry Bureau (CIB) will launch publicity programmes, for example the production and broadcast of Announcement for Public Interest, to promote Hong Kong's service industries to the international markets and to enhance the public and service providers' understanding of quality services as well as their support for it.

(2) *Continue to co-ordinate the Government's efforts in supporting the development of professional services*

The Government has adopted a two-pronged approach in promoting the development of the professional service sectors. Firstly, we provide assistance to individual professional service sectors to help them tap external markets. Given that different sectors are faced with different problems in the process and have different interests, the assistance is provided by relevant bureaux and departments. BSPU maintains close contact with these bureaux and departments to monitor the situation and identify areas for further improvement or support. It also liaises with the Office of the Government of the HKSAR in Beijing and the Hong Kong Trade Development Council (TDC) to disseminate, directly or through relevant departments, to professional bodies the updated information about Mainland's market and regulations.

Secondly, we provide support to facilitate the development of the professional service sector as a whole. The work in this area can be further divided into two parts:

- Promotional activities: BSPU is responsible for organising promotional activities concerning the professional service sector as a whole. For example, last year we produced VCDs to promote the professional services of Hong Kong to the Mainland and distributed them to the Mainland enterprises through TDC. In the coming year, we will collaborate with the Joint Professional Centre to set up a website on professional services of Hong Kong. We also plan to organize seminars to discuss with various professional sectors about the changes and business opportunities brought about by China's accession to WTO.
- Professional Services Development Assistance Scheme: The Scheme, which is administered by BSPU, aims at providing funding support to the professional service sectors for launching projects conducive to their development. Please refer to item (3) below for the latest developments.

(3) *Introduce a Professional Services Development Assistance Scheme to help raise the standard of professional services*

The Professional Services Development Assistance Scheme was open for applications on 28 February 2002. We expect to complete the vetting of applications in July and invite second tranche of applications in August to September.

CIB's resources (excluding personal emoluments) involved in items (1) and (2) above amount to around \$6.85m. That includes the estimated expenditures of \$3.4m under Subhead 838 (Minor consultancy studies), \$2m under Item 010 of Subhead 700 (Publicity programme to maintain Hong Kong's position as a pre-eminent services centre by promoting quality service) and \$1.45m under Subhead 149 (General departmental expenses). As mentioned above, other bureaux are also involved in promotion work and providing support relating to these two items. We have not compiled statistics on the resources contributed by them.

As regards item (3) above, we have set aside \$33m in 2002/03 to fund the approved projects.

The main functions of the Hong Kong Economic and Trade Office (ETO) in Guangdong will include - (a) to promote trade between Hong Kong and Guangdong through enhanced communication and cooperation with the provincial government and different levels of local authorities; (b) to reflect and follow up trade-related issues of common concern among Hong Kong businessmen to the relevant Guangdong authorities; (c) to gather and disseminate the latest information on commerce and trade policy and legislation in Guangdong; (d) to publicize the excellent investment environment of Hong Kong in order to facilitate more investment between the two places and to enhance trading opportunities; and (e) to cultivate a positive image of Hong Kong so as to facilitate business promotion. As establishment of the ETO is still in the preparatory stage, details on its work plan on specific trade issues in 2002-03 have yet to be worked out. However, it is expected that the ETO will first focus on establishing working relationships with the government authorities and industrial and trade associations in Guangdong and gaining deeper understanding of the concerns and needs of Hong Kong businessmen with a view to formulating the detailed and long-term work plan of the ETO.

The main tasks include formulating HKSTPC's policy directions, following up the current major programmes and projects, developing new focuses for its projects and services, as well as handling matters in relation to its transition after the merger. HKSTPC's transitional matters, such as its organisational structure, staffing and establishment, have generally been settled. Besides, the newly appointed Chief Executive Officer will assume duty in April 2002. With its satisfactory progress of development, the Science Park will commence to operate in mid-2002.

Regarding the promotion of innovation in technology, the HKSTPC will place its emphasis on the nurturing of technology-based start-ups. Since the expansion of the incubation programme in September 2001, the response from the business sector has been encouraging, with more than 40 technology start-ups joining the Scheme. This year, the HKSTPC will further strengthen its incubation programme, provide tenants of the Science Park and incubatees with training and technical support, and develop network with the universities. The HKSTPC also actively seeks opportunities for collaborations with the science parks in the Mainland. In November 2001, it signed a collaboration agreement with the Bureau of Foreign Trade and Economic Cooperation of Guangzhou Municipality ("the Bureau") to spearhead cooperation in scientific and technological development between Guangzhou and Hong Kong. The Bureau led a delegation comprising key enterprises in Guangzhou and the Guangdong Province for participation in the business-matching sessions of the TechWorld 2002 hosted by the HKSTPC on 19 March 2002. According to the preliminary estimates made by the HKSTPC, the costs involved for the above programmes will be about \$50m, which will be met by the HKSTPC.

Reply:

The increase in provision for 2002-03 is for enhancing existing services and is \$106.6 m (9.7%) higher than the revised estimate for 2001-02 mainly due to –

- (a) the creation of 121 posts (40 posts for manning customs facilities at the Container Terminal No. 9, 48 posts for the expansion of Lok Ma Chau Control Point and 33 posts for facilitating cross-boundary traffic) as well as the transfer of 24 posts from the Marine Department to man harbour launches. The provision for these new posts is partly offset by a net deletion of 50 posts upon the establishment of a new Intelligence and Co-operation Branch, implementation of Electronic Data Interchange services for cargo manifest and completion of short term projects, and 49 posts deleted under the Enhanced Productivity Programme;
- (b) an increase in recurrent departmental expenditure arising from the facilities in the new Container Terminal No. 9, the procurement of two mobile X-ray vehicle scanners for Man Kam To and Sha Tau Kok Control Points and the implementation of the Case Processing System and the Electronic Data Interchange System for cargo manifest; and
- (c) non-recurrent expenditure for the procurement of four high speed pursuit crafts for the purpose of suppressing smuggling activities along the sea boundaries.

On the other hand, there is an increase of \$7 m for the estimates of expenditure under Programme (3), of which the establishment of the Intelligence and Co-operation Branch also accounts for one of the two major items of expenditure. What is the actual financial provision for this new Intelligence and Co-operation Branch? Please also advise this Council on the functions of the Branch and whether additional recruitment of manpower is needed.

Reply:

The resources required for establishing the Intelligence and Co-operation (IC) Branch is \$24.82 m, of which \$20.94 m will be met by internal redeployment involving a re-distribution of the existing resources among the five programme areas under the purview of the Department. In this connection, an amount of \$2.85 m will be redeployed to Programme (3) which accounts for about 41% of the total increase of \$7.0 m in the provision for the programme area in 2002-03, while another amount of \$3.06 m will be redeployed to Programme (5) which accounts for about 82% of the total increase of \$3.73 m in the provision for that programme area. The net additional provision from central government for establishing the IC Branch is \$3.88 m.

The functions of the IC Branch are -

- (a) to steer and co-ordinate departmental intelligence activities;
- (b) to formulate policies, guidelines and procedures on intelligence work for application across the Department;
- (c) to produce strategic intelligence to support top level decision making;
- (d) to provide tactical/operational intelligence timely and directly to field officers to enhance efficiency in various operational activities;
- (e) to co-ordinate the sharing of intelligence across formations;
- (f) to research on intelligence collected by formations to develop new intelligence or add value to existing intelligence; and
- (g) to be responsible for the liaison and co-operation work with overseas Customs administrations and Mainland's Customs authorities on intelligence exchange and other mutual assistance matters.

The IC Branch will be manned by existing staff and additional recruitment of manpower is not required.

Question : What kinds of strategic commodities are covered under the Strategic Trade Control System? Under the import and export licensing control systems for licensable items, what items are required to apply for import or export licences?

Reply:

Under the Import and Export Ordinance, the import, export, transshipment, and in some cases, transit of strategic commodities are subject to licensing control. Such strategic commodities are listed in the Schedules to the Import and Export (Strategic Commodities) Regulations. They include munitions items and a wide variety of goods that are capable of use for both industrial and military purposes, such as chemicals, electronic components, computers, telecommunication equipment, as well as articles that might be used in the development, production etc of chemical, biological or nuclear weapons.

Apart from strategic commodities, some 30 other categories of articles are also subject to import and export licensing control under various legislations for different purposes, such as to safeguard public health, security, public revenue, or to discharge Hong Kong's international obligations. For instance, under the Import and Export (General) Regulations, the import and/or export of textiles, pesticides, pharmaceutical products and medicines, frozen or chilled meat and poultry, left hand drive vehicles, outboard engines exceeding 111.9 kilowatts and optical disc mastering and replication equipment have to be covered by licences.

When we sought funding from the Finance Committee, we included a cost-benefit analysis of the outsourcing of non-core activities which showed that outsourcing would be more cost-effective when compared with in-house service. The cumulative net savings expected to be achieved through the outsourcing project over the five-year period was estimated to be \$32.8 million.

2. The non-core activities, including the development of new computer systems for trade marks and designs, enhancement of the patent computer system, on-going IT support and front/back office operations, have been outsourced as a package under a contract which commenced on 1 December 2001.

3. While the contract is still at an early stage, we envisage that the estimated cumulative net savings of \$32.8 million will be realised upon the completion of the project.

Reply:

Invest Hong Kong's investment promotion (IP) activities are sector-based as opposed to geography-based. It is therefore not possible to specify the resources dedicated to IP work or activities in or related to any one economy including Mainland China. Suffice it to say that the purpose of all IP activities is to attract inward investment to Hong Kong particularly in the priority sectors, regardless of where the investors are based.

Invest Hong Kong is supported by units in the Hong Kong Economic & Trade Offices (ETOs) overseas and will allocate a budget to each ETO to enable the IP unit to carry out a programme of activities in accordance with a business plan agreed between the department and the ETO. For Mainland China, the first ETO is being planned for Guangzhou and a business plan is being developed. Initially the IP Unit of the Guangzhou ETO can be expected to target private enterprises in priority sectors and to organize sector specific seminars, workshops and promotional activities. Details are being worked out pending the establishment of the Guangzhou ETO.

What are the impacts of increase or decrease in the amount at market value of the in-flow of foreign direct investment on the departmental establishment and expenditure?

Reply:

The substantial increase in Inward Direct Investment in 2000 is due mainly to -

- (a) major merger and acquisition activities in the telecommunications sector in 2000;
- (b) the reinvested earnings of foreign companies in Hong Kong due to improved corporate profitability and increased confidence in Hong Kong;
- (c) recovery from the economic turmoil of the recent past;
- (d) transnational companies planning to invest in Mainland China 'parking' funds in Hong Kong in anticipation of China's entry into the WTO; and
- (e) the increasing importance of investment from Mainland China to the development of the Hong Kong economy.

The Inward Direct Investment in 2000 came mainly from three enterprise groups, including investment holding, real estate and various business services (68%), wholesale, retail and import/export trades (13%) and banks and deposit-taking companies (7%).

The global slowdown in economic growth and reduction in cross-border mergers and acquisitions would likely cause a drop in Foreign Direct Investment flows in 2001 and a lull in 2002. However, we are hopeful that the setback would be temporary and we expect direct investment flow to increase again from 2003 and grow over the medium term.

There is no direct relationship between the value of Inward Direct Investment and the department's establishment and expenditure. During the Inward Direct Investment boom in 2000, the department had coped with the demands from a great number of foreign investors mainly through prioritisation.

- (a) The Trade and Industry Department is involved in supporting the activities of the Mainland and HKSAR Joint Commission on Commerce and Trade, co-chaired by the Secretary for Commerce and Industry on the Hong Kong side and a Deputy Minister of the Ministry of Foreign Trade and Economic Cooperation (MOFTEC). A number of working groups have been established under it, including the Working Group on Trade with the Director-General of Trade and Industry as co-convenor. Matters for discussion under the Working Group include trade and trade-related subjects of common interest or mutual concern.
- (b) The Trade and Industry Department will continue its efforts in monitoring the implementation of the market liberalisation commitments made for China's accession to the World Trade Organisation (WTO). In 2002, the Mainland and HKSAR Joint Commission on Commerce and Trade will organise a series of seminars on China's accession to the WTO. Mainland officials will be invited to speak at the seminars, and to discuss with Hong Kong businessmen issues concerning the implementation of the liberalisation commitments and business opportunities for Hong Kong. In addition, the Department will enhance liaison with relevant Mainland authorities to understand the latest market developments, and disseminate information to the business community accordingly.

We have not set aside a special provision for the tasks mentioned above as they are largely carried out by existing manpower resources available in the Mainland and Asia Branch of the Asia Division. On a day to day basis, these tasks are carried out by a Principal Trade Officer, a Trade Officer and an Assistant Trade Officer under the supervision of an Assistant Director-General and a Deputy Director-General.

What are the reasons? Will there be a corresponding increase in the manpower and expenditure? Or will the extra workload be absorbed by existing resources? Please provide details if additional resources are required.

Reply:

Strategic commodities cover, among other things, various dual use high-tech products which have wide application in various trade and industry sectors. The most common types of strategic commodities include electronic components, computers, telecommunication equipment and information security products.

The estimated number of strategic commodities licences to be issued in 2002 is projected based on the licensing pattern in 2001, which showed a general increasing trend for licences covering electronic components and information security products. We envisage that, as e-commerce becomes more popular and as demand for high-tech goods for use by the business community increases, the import and export activities relating to strategic commodities will continue to grow in 2002. We further envisage that the more powerful or sophisticated products falling under the statutory control system may become more widely available during the course of the year. Taking into account all these considerations and based on past experience, we estimate that there would be a 20% increase in licences covering the import and export of strategic commodities in 2002.

The Department will absorb the additional workload through productivity enhancement and internal redeployment of resources. No additional manpower resources or expenditure would be required in this respect.

Question : Under "Matters Requiring Special Attention in 2002-03", the Trade and Industry Department has indicated that it will implement other support measures recommended by the Small and Medium Enterprises (SME) Committee, in addition to overseeing the four SME funding schemes. Please provide the budget for and details on the implementation of these measures.

Asked by: Hon. HUI Cheung-ching

Reply:

In its report to the Chief Executive in June 2001, the SME Committee (SMEC) recommended over 30 measures in the areas of SME financing, business environment, corporate governance and culture, human resources, technology application, and market expansion, to help SMEs further develop, including setting up four SME funding schemes.

The four SME funding schemes were launched in December 2001 and January 2002 respectively. The Department has also started to implement, in collaboration with other government bureaux and departments, trade and industry associations, and industry support organisations, all the other recommendations of the SMEC. The major ones are as follows:

- (a) the Department has upgraded its SME Information Centre into the Support and Consultation Centre for SMEs (SUCCESS), which came into operation in November 2001. Through partnership with more than 60 major trade and industry associations, support organisations, professional bodies, private firms, and government departments, SUCCESS provides SMEs with a comprehensive range of free information, business advisory services and facilities under the same roof. It also regularly runs seminars on topics of interest to SMEs;
- (b) a Roundtable on SME Financing has been set up recently under the SMEC to consider issues and developments relating to SMEs' financing needs, and to suggest measures that will facilitate SMEs to raise capital for short- and long-term development. The Roundtable comprises SMEC members, individual SMEs, and representatives from SME associations, lending institutions, financial institutions, the Hong Kong Monetary Authority, and relevant government bureaux and departments. The Roundtable convened its first meeting on 18 March 2002;
- (c) the existing Pilot Mentorship Programme for SMEs will be expanded. In this regard, we will work in partnership with various trade and industry associations, industry support organisations, and professional bodies so that more SMEs may benefit. We aim to launch the expanded Programme in the second quarter of 2002; and
- (d) we will encourage and facilitate trade and industry associations to work closely with local higher education institutions, with a view to coming up with practical measures to attract more local talents to join local industries upon graduation. For example, we will explore the feasibility of running a pilot practicum programme in SMEs for undergraduates in various industry-related disciplines.

In order to cope with the additional workload arising from implementing the recommendations of the SMEC, three non-directorate civil service posts will be created in 2002-03. Further, the Department will engage 35 non-civil service contract staff.

The setting up of the four SME funding schemes involves a total commitment of \$7.5b, with an expected maximum expenditure of \$1.9b. We have also earmarked about \$3.7m in 2002-03 for implementing the activities run by SUCCESS. Any additional resource requirement that is needed to implement the other new initiatives will be absorbed by the Department within its existing resources.

It was a very useful source of information for SMEs and service providers. The Plan was updated in 2001, and will be updated again in 2002. The updated version will be available in the second half of 2002.

When the Plan was first published in 1999, it was available in hard and soft copies (soft copy is available on the website of the Virtual SME Information Centre (VSMEIC) ([www.sme.gcn.gov.hk](http://www.sme.gcn.gov.hk))). The 2001 version was available in soft copy only. To facilitate more regular updating of the information in the Plan, we plan to issue updated versions in soft copies only in future. We estimate that it will cost about \$20,000 to update the Plan in 2002. Provision has been made for this purpose.

Question : It is estimated that three civil service posts and 35 non-civil service posts will be created this year for the implementation of support measures recommended by the Small and Medium Enterprises (SME) Committee. Apart from the four SME funding schemes, will the Government let the Council know the details of other support measures and the budget for each measure?

Reply:

In order to cope with the additional workload arising from implementing the recommendations of the Small and Medium Enterprises Committee (SMEC), three non-directorate civil service posts will be created in 2002-03. Further, the Department will engage 35 non-civil service contract staff. These additional manpower are deployed as follows:

- (a) a Principal Trade Officer, an Executive Officer I and 35 non-civil service contract staff are responsible for helping to implement the four SME funding schemes; and
- (b) a Trade Officer is responsible for operating the new Support and Consultation Centre for SMEs (SUCCESS).

The SUCCESS, which started operation in November 2001, provides SMEs with convenient one-stop services. Through partnership with more than 60 major trade and industry associations, support organisations, professional bodies, private firms and government departments, SUCCESS provides SMEs with a comprehensive range of free information, business advisory services and facilities under the same roof. It also runs regular seminars on topics of interest to SMEs.

The Department is also helping to implement the other recommendations of the SMEC. The major ones include:

- (a) a Roundtable on SME Financing has been set up recently under the SMEC to consider issues and developments relating to SMEs' financing needs, and to suggest measures that will facilitate SMEs to raise capital for short- and long-term development. The Roundtable comprises SMEC members, individual SMEs, and representatives from SME associations, lending institutions, financial institutions, the Hong Kong Monetary Authority and relevant government bureaux and departments. The Roundtable convened its first meeting on 18 March 2002;
- (b) the existing Pilot Mentorship Programme for SMEs will be expanded. In this regard, we will work in partnership with various trade and industry associations, industry support organisations, and professional bodies so that more SMEs may benefit. We aim to launch the expanded Programme in the second quarter of 2002; and

- (c) we will encourage and facilitate trade and industry associations to work closely with local higher education institutions, with a view to coming up with practical measures to attract more local talents to join local industries upon graduation. For example, we will explore the feasibility of running a pilot practicum programme in SMEs for undergraduates in various industry-related disciplines.

The setting up of the four SME funding schemes involves a total commitment of \$7.5b, with an expected maximum expenditure of \$1.9b. We have also earmarked about \$3.7m in 2002-03 for implementing the activities run by SUCCESS. Any additional resource requirement that is needed to implement the other new initiatives will be absorbed by the Department within its existing resources.

Question : What was the total number of projects financed by the Innovation and Technology Fund in the 2001-02 financial year? Please provide a brief on the projects which were given the largest and smallest sums of grants, indicating the respective figures.

Reply:

During the past 11 months of the financial year 2001-02, the Innovation and Technology Fund financed a total of 97 projects. The project receiving the largest sum of grant was "Photonic Packaging Laboratory" under the Innovation and Technology Support Programme. The grant for this research project, which amounts to HK\$11.5m, was used to establish a photonic component and subsystem prototype development laboratory with a view to assisting the industry to develop the method and process of photonic components packaging, and providing training to local talents and technical support to the local photonic industry. The project receiving the smallest sum of grant was "EcMap, an Integrated E-commerce Marketing System, to Enable Cost-effective and Result-based Web-site Marketing" under the University-Industry Collaboration Programme. The grant for this research project, which amounts to HK\$150,000, was used to develop a web-based marketing and transaction system.

The consultancy study on the Hong Kong Productivity Council (HKPC) is near completion. The consultant has made a number of recommendations on the future role and focus, business model, organisation and management, funding arrangement and performance measures of the HKPC. The Commissioner for Innovation and Technology will present the findings and recommendations of the consultancy study to the Panel on Commerce and Industry of the Legislative Council in April 2002.

In view of the wide coverage of the recommendations, the Government has to discuss in detail with the HKPC on how to take forward and implement the recommendations. As such, the resource implications in implementing the recommendations cannot be assessed at this stage. The Government, however, will ensure the continued effective use of resources by HKPC in fulfilling its public mission and delivering its services when it implements the recommendations.

  - (c) What will be the main research areas of ASTRI in 2002-03?

Reply:

- (a) The Hong Kong Applied Science and Technology Research Institute (ASTRI) intends to recruit about 20 additional staff in 2002-03. Out of which, 4 would be administrative and support staff and the remainder would be R&D staff.
- (b) The staff of ASTRI are employed on a time-limited contract basis. In determining the pay packages of its R&D staff, ASTRI has made reference to those of the researchers in local universities and similar positions in the market. As for the pay packages of its administrative and support staff, reference has been made to those of similar positions in both the Government and the market. Since ASTRI is a subvented organisation, in general, the terms of service for its staff are no better than those of the comparable grades in the civil service.
- (c) In 2002-03, the research areas of ASTRI will include optical, wireless, Internet contents and applications, and semi-conductor design, etc.

Question : Will the government inform this Council of the progress of the operation of the Hong Kong Jockey Club Institute of Chinese Medicine (HKJCICM) since its establishment in May 2001? What research projects will be implemented within this year? What are their details? Has the Government made estimation on the provisions for those projects?

Reply:

Soon after the establishment of HKJCICM in May 2001, a 13-member Board of Directors, comprising representatives from the Government, the Hong Kong Applied Science and Technology Research Institute Co. Ltd., the Hong Kong Jockey Club (HKJC) and the business sector, was appointed. In 2001-02, 4 Board of Directors meetings were held to discuss the start-up operation and long-term development strategies of HKJCICM. HKJCICM also appointed its Executive Director and other key staff in October/November 2001 to develop and implement its research and development (R&D) programmes and operating strategies of HKJCICM. Separately, HKJCICM has formulated its long term business plan, and it has also formed a Strategic Advisory Panel and a Technical Advisory Panel to provide strategic advice on future directions of HKJCICM and technical advice on individual R&D projects respectively.

HKJCICM is now planning and arranging for its first R&D project on Chinese medicine. Since the detailed arrangements are still under discussion, particulars and financial provision of the project are not available for the time being. Nevertheless, it is planned that the project would be funded by the \$500m donation from the HKJC.
