The remaining commitment is a capital project of \$0.500M approved in the course of 2001-02 to fund the nomination of representatives of arts interests for the Hong Kong Arts Development Council.

Reply :

The Government completed a review of the role and functions of District Councils (DCs) in 2001 and has commenced implementing the recommendations arising from the review. Allocation of funds for implementing these recommendations was approved by Finance Committee on 7 December 2001. In 2002-03, \$101,791,000 has been earmarked under Head 63 for enhancing the role and functions of DCs, including \$41 million for DCs' community involvement projects and minor environmental improvement projects, \$43.6 million for allowances for DC members, \$12 million for additional staff and \$5 million for training.

The Chief Secretary for Administration has issued a circular in January 2002 to all policy secretaries and department heads, promulgating measures to enhance the role and functions of DCs,



including proper consultation with DCs on major district issues, regular meetings with DC members and the need to take DCs' views into account in the decision making process. We will monitor progress to ensure the recommended measures are properly carried out.

As the rates of honorarium are determined on different basis including per attendance, per case or annual/monthly rates, it is difficult to pinpoint which are the highest. As details of the celebration programme have yet to be worked out, we are unable to provide a breakdown of the estimated expenditure at this stage.
- (b) An inter-departmental working group has been set up to develop a framework for rural elections. The working group is chaired by a Deputy Secretary for Home Affairs. It is proposed that village representative elections should be brought under statutory control.

The Home Affairs Bureau is responsible for preparing the required legislation and steering the relevant Bill through the legislative process. Within the Bureau, the subject is handled by a Deputy Secretary for Home Affairs with the support of a Principal Assistant Secretary and an Assistant Secretary. So far, we have been redeploying existing resources to cope with the additional work. Once we have decided on the procedures and arrangements for the village representative elections, we will determine the resources required to conduct the elections.

Reply : The Hong Kong Sports Development Board (SDB) is responsible for elite training in Hong Kong. The amount of government recurrent subvention allocated to SDB for 2001-02 and 2002-03 is \$190.5 million and \$189.7 million respectively.

The amount provided for elite training by SDB in 2001-02 and 2002-03 is \$132 million and \$135 million respectively, of which \$87.9 million for both years is funded by government and the rest funded by other incomes of SDB. Thus, government funding for elite training accounts for about 3.65% and 3.58% of the overall provision for recreation and sport in 2001-02 and 2002-03 respectively.

So far, there are no further court challenges against the electoral arrangements of other villages.

In view of the judgement of the Court of Final Appeal, the Government decided to develop a framework for village representative elections and bring such elections under statutory control. We are now re-deploying existing resources to cope with the preparatory work. We will determine the resources required to conduct the village representative elections once we have decided on the procedures and arrangements for the elections.

The Chief Secretary for Administration has issued a circular to all policy secretaries and department heads promulgating these measures. We will monitor progress to ensure the recommended measures are properly carried out. We will also continue to explore means to further enhance the role and functions of District Councils.

(b) Allocation of funds for implementing the recommendations arising from the District Councils Review was approved by Finance Committee on 7 December 2001. In 2002-03, \$101,791,000 has been earmarked under Head 63 for enhancing the role and functions of DCs, including \$41 million for DCs' community involvement projects and minor environmental improvement projects, \$43.6 million for allowances for DC members, \$12 million for additional staff and \$5 million for training. At the bureau level, no resources have been earmarked to monitor the implementation or to further enhance the role and functions of District Councils. The Bureau will deploy existing resources to carry out the necessary work.

Projects promoting the rule of law are funded alongside those on promoting civic awareness, human rights and a better understanding of the Basic Law. Reply :        The Government’s policy objective on building management is to help private building owners to help themselves in properly and effectively managing and maintaining their properties. As the policy bureau responsible for building management, the Home Affairs Bureau’s primary role is to maintain a sound legal framework through constant reviews and improvements to the Building Management Ordinance (BMO), as well as to provide advisory services to building owners on building management issues through the Home Affairs Department (HAD).

On the legislative front, our Bureau is working closely with the Sub-committee of the LegCo Panel on Home Affairs in drawing up a series of amendments to the BMO which aim at improving the building management regulatory regime in different aspects. Separately, we plan to submit to LegCo in the coming months a proposed new Regulation under the BMO for the purpose of stipulating the detailed requirements of the insurance policy for third party risks which an Owners’ Corporation (OC) has to procure for building owners. We are also planning to amend the BMO to enable OCs to borrow money from the Government’s Comprehensive Building Safety Improvement Loan Scheme for the sake of complying with statutory building improvement orders. We will consult the Panel on this proposal and the associated implementation arrangements shortly.

As regards support and advisory services, we assist building owners to form OCs under the BMO, organize various kinds of promotional activities such as seminars, training courses, talks and exhibitions for OC office bearers to enhance their building management knowledge, as well as offer free enquiry service and arrange free expert advice from legal, building and related professionals on building management. These services are currently provided by HAD through its new Division on Building Management, the District Building Management Liaison Teams (DBMLTs) in each of the 18 District Offices, and the three Building Management Resource Centres (BMRCs) respectively in Central, Yaumati, and Tsuen Wan. The new Division, the DBMLTs and the third BMRC in Tsuen Wan were successively established from mid 2001 to early 2002 so as to strengthen our resources on building management services.

In 2002-03, with the above strengthened resources on building management, our Bureau and HAD will continue to adopt a pro-active and outreaching approach in providing the above support services to building owners. In addition, HAD is planning to set up the fourth BMRC in Shatin in order to strengthen the support for OCs, and is exploring the feasibility of providing a non-statutory mediation mechanism at the BMRCs with the objective of reducing the number of disputes eventually filed with the court. We will also continue to work closely with the Fire Services Department and Buildings Department to ensure that building owners could comply with the requisite building and fire safety requirements of their buildings.

- (1) We plan to amend the Sex Discrimination Ordinance and the Family Status Discrimination Ordinance in 2002-03. The actual timing for introduction of the bill will depend on the drafting progress, which will take some time. The legislative amendment exercise will be steered by the Bureau's existing staff responsible for overseeing the two ordinances. The legislative amendments do not have implications on the Home Affairs Bureau's expenditure.

- (2) The Race Relations Unit will be staffed by a senior programme officer, two programme officers and a programme assistant. They will be employed on non-civil service contract terms. The estimated provision for 2002-03 is \$1.7 million. This comprises \$1.3 million for the four posts and \$0.4 million for operational expenses.

The Unit will be responsible for the logistical or 'executive' aspects of our work in this area. Its functions will include -

- devising and producing publicity materials, including commissioning contractors and/or non-governmental organisations (NGOs) to carry out tasks requiring special expertise;
- providing secretarial services to the Committee on Racial Harmony;

- maintaining a hot line for enquiries and complaints and possibly including counselling;
- outreach work to schools to put across the message that the Government takes this issue seriously and proactively, so fostering a culture of tolerance and mutual respect among the young and in the community as a whole;
- administration of the equal opportunities funding scheme;
- with the assistance of NGOs, co-ordinating and training volunteers to run induction programmes for non-Chinese New Arrivals; and
- such other duties as the Home Affairs Bureau may from time-to-time direct: to ensure flexibility in the allocation of new tasks.

What are the difficulties that have been encountered by the Government? What areas will be covered in the review? What is the specific timetable and what are the resources involved?

Reply :

The review of the Personal Data (Privacy) Ordinance (PDPO) is to address the difficulties encountered by relevant parties in the application of the PDPO since its operation and to put beyond doubt the meaning of particular provisions. The proposed amendments/ clarifications to the PDPO will all be “technical” in nature in that they do not touch on any fundamental concepts.

For example, the Commissioner may issue under section 8(5) of the PDPO guidelines “for the guidance of data users”. However, such guidelines may be applicable to data subjects, e.g. in their lodging of complaints. Another example is under section 26(1) of the PDPO, a data user shall erase personal data held by him/her where the data are no longer required for the purpose for which the data were used subject to two exceptions. Similar provision is contained in data protection principle 2(2) in Schedule 1 to the PDPO. Strict compliance with these provisions would require a data user to go through the documents on a frequent and regular basis to erase, item by item, any personal data no longer required for the particular purpose specified at the time of their collection. This would impose a nearly impossible burden on at least some data users.

We are working towards the target of having an amendment bill setting out all the proposed “technical” amendments introduced into the Legislative Council in the legislative year 2002-03.

For proposed amendments to the PDPO which may require additional resources, we shall address the question as to how the resources required can be made available before finalisation of the proposal.

Question : How much resource will be saved after implementation of the new business-friendly licensing for hotels and guesthouses where operators can apply for multiple year licences? Will the Administration consider allocating more resources to strengthen enforcement action against unlicensed guesthouses / bedspace apartments?

Asked by : Hon. YOUNG, Howard

Reply : With the multiple year licensing scheme for hotels and guesthouses implemented with effect from 21 December 2001, we expect that in the long run there will be savings in terms of staffing and other recurrent costs. However, no savings could be achieved in the first year of implementation of the multiple year licensing scheme because all normal licensing procedures for the applications are still required to be performed in the first year. Savings could be achieved from the second year onwards when the number of applications for renewal of hotels and guesthouses licences is reduced.

At present, there are 939 licences issued to hotels and guesthouses. Since the implementation of the scheme, 173 applications for multiple year licence had been received of which 149 were approved. On the other hand, 20 licensees did not apply for a multiple year licence. Given that the decision of operators on whether to apply for the multiple year licences is based on commercial considerations and our approval of such applications depends on the operators having a good track record of compliance with the fire and building safety standards, it is difficult to estimate the amount of savings at this stage. We will be in a better position to assess the amount of savings one year after the implementation of the scheme.

The Office of the Licensing Authority plans to conduct a review on its overall workload in early 2003 (i.e. one year after the implementation of the multiple year licensing scheme), and will consider allocating surplus resources to strengthen the policing and prosecution actions against unlicensed guesthouses and bedspace apartments.

Reply : (a) In monitoring and assessing the provision of services to new arrivals from the Mainland, the Home Affairs Department (HAD) is responsible, among other things, to coordinate the services of various Government departments and Non-governmental organisations (NGOs). At central level, Director of Home Affairs (DHA) chairs a Coordinating Committee on New Arrival Services to coordinate the Government's efforts in the provision of services to new arrivals. DHA also chairs a quarterly round-table meeting with major NGOs providing services to new arrivals to gauge their views on the effectiveness of new arrival services and the needs of new arrivals. At district level, coordinating committees are set up for NGOs and Government departments to discuss new arrival issues in the districts.

HAD also renders necessary assistance to the NGOs in their provision of services, such as identification of service location and liaison with other Government departments. Besides, HAD conducts a regular survey on the profile and needs of new arrivals and the survey results are compiled into quarterly reports, which are promulgated to relevant Government departments and NGOs to facilitate their service planning.

- (b) The provision to HAD in 2002-03 for monitoring and assessing of provision of services to new arrivals is \$6.83 million. They are mainly the salaries of the relevant personnel responsible for the above duties.

Reply : (a) The Home Affairs Department is organising a Regional Conference on Private Building Management scheduled for 6 July 2002 at the Hong Kong Convention and Exhibition Centre.

The Regional Conference is a whole-day function. We intend to invite suitable guest speakers from the Mainland, Macau, Australia and Singapore. Four panel discussions led by representatives from Government departments and professional bodies will also be arranged. Target audience will include professional and practitioners of related fields, District Council Members and the public, in particular Owners' Corporation/Mutual Aid Committee members.

The Regional Conference is the first of its kind organised in Hong Kong by the Home Affairs Department. Whether the event would be held regularly would depend on the success and response to it. The number of participants for the Regional Conference is anticipated to be about 1 200.

The objective of these missions is to strengthen ties between Hong Kong and its major trading partners, and to promote Hong Kong as Asia's world city and the pre-eminent gateway to China.

2. In late January 2002, the Financial Secretary led a delegation of eight Hong Kong business leaders to attend World Economic Forum's annual summit in New York. Other outward missions for 2002 being planned are expected to cover countries in North America, Europe, Australia and the Asia Pacific region including Mainland China. However, details have yet to be finalized. The actual expenditure on these visits depends on (a) whether the planned visits will take place, (b) the destination and scale of the missions and (c) the related activities to be organized. These expenditures may also be covered under different programme areas of various government departments and offices.

2. The estimate of \$43.726M for 2002/03 for “Visitors to Hong Kong and overseas speaking engagements” represents an increase of \$30.614M over the revised estimate of \$13.112M for 2001/02. The increase is mainly due to change in accounting arrangement for the allocations of \$28.5M (Item (b) above) for promotional and publicity projects outside Hong Kong and \$2.6M (Item (c) above) for funding of PR activities of international conferences in Hong Kong totalling \$31.1M. Funding for projects under items (b) and (c) above used to be under Capital Account items, but the \$31.1M will be transferred to Recurrent Account in 2002/2003 due to the recurrent nature of these projects. The increase of \$31.1M was partly offset by reduced operating expenses (for Item (a) above) under the Enhanced Productivity Programme.

New scoreboards providing basic functions of displaying scores and time were, however, installed at the Tuen Mun Tang Shiu Kin Sports Ground in 2000 and the Sai Kung Tang Shiu Kin Sports Ground in 2001 at a cost of \$1.70 million and \$2.93 million respectively.

In 2002-03, the Leisure and Cultural Services Department plans to replace/install scoreboards in the following three venues –

- (a) Mong Kok Stadium - \$3.2 million;
- (b) North District Sports Ground – \$2.5 million; and
- (c) Wan Chai Sports Ground - \$8 million.

The scoreboard to be installed in the North District Sports Ground and the Mong Kok Stadium can perform only basic functions of displaying scores and characters, showing real time and match time. The system to be installed in the Wan Chai Sports Ground, which is more expensive, will be capable of performing the following additional functions –

- (a) displaying graphics, animation and video replay to make the event more appealing, informative and educational;

- (b) connected to the existing software of the photo-finishing equipment, the results of track events can be displayed and made known to all audience as soon as the athletes pass the finishing line ; and
- (c) connected to video-taking, field events can be relayed and displayed simultaneously on the scoreboard.

A more elaborate system is considered necessary for the Wan Chai Sports Ground because it is one of the few major venues in Hong Kong for holding international and important local athletic and sports competitions.

In 2001-02, \$101 million was spent on recreation and sports activities for the general public. In 2002-03, a total of \$112 million has been earmarked in our budget for recreation and sports programmes.
- (b) In 2001-02, four major outdoor “Asia ethnic cultural events” for the Filipino, Indonesian, Nepalese and Thai nationals residing in Hong Kong have been jointly organised with the respective Consulates-General in Hong Kong. The total attendance was 11 160 comprising both local citizens and the Asian minority residents. In 2002-03, four similar events will again be held between April and November 2002.

From time to time, the ethnic minority communities hire the Department’s civic centres such as the City Hall, Sheung Wan Civic Centre, Tsuen Wan Town Hall, Yuen Long Theatre and Queen Elizabeth Stadium for organizing cultural activities. In 2001-02, they have made 82 bookings while for 2002-03, 28 bookings have been received so far. Hirers include the Indian, Nepalese and Filipino communities. Some of the bookings are supported by the Department under its reduction of hire charges scheme.

For 2002-03, researchers from a Mainland cultural institution will be invited to conduct a joint study on traditional Chinese buildings in Hong Kong, to research into their types, functions and history, and to identify and recommend techniques to better restore these buildings.
- b) The estimated expenditure for the project in 2002-03 is \$500,000, covering, for a team of five academics and experts from the Mainland, air-passage (\$40,000), accommodation for four months (\$50,000), honoraria (\$300,000), and equipment and consumable costs and contingencies (\$110,000).

- c) The joint project is anticipated to enhance professional exchanges between Mainland and local heritage conservation personnel, and the Department can benefit from the professional views of the Mainland experts in our heritage conservation work.

a) The autumn thematic festival in 2002 is tentatively entitled "Fusion of the Arts" festival. Aiming to highlight Hong Kong's position as Asia's world city and to encourage Hong Kong people to embrace an international perspective, the festival will feature innovative and high quality cross-cultural performances. The programme focus will be on Asian elements expressed in a contemporary style.

b) The estimated budget for the festival is \$14.77 million. It will be organized by the Leisure and Cultural Services Department's Festivals Office which consists of 14 permanent staff. This office also organizes the International Arts Carnival in the summer. Temporary staff will be engaged to cope with the seasonal workload during the festival period.

- (a) The Hong Kong public libraries are planning to use the new smart ID cards scheduled for issue to the public in mid-2003 by the Immigration Department as library cards. Library users will be given the option of either using their smart ID cards as library cards or applying for traditional plastic library cards. If a reader chooses to use the smart ID card, the library automation system will enable the use of the ID card number stored in the smart card to access library services provided by all the public libraries in Hong Kong;



- (b) The total funding required in 2002-03 for implementing this service will be \$3.1 million, of which \$1.2 million is the expenditure for software customization and \$1.9 million for hardware and project implementation services;
- (c) Very minimal saving in manpower resources is anticipated from the use of smart ID cards as library cards. However, the following benefits can be expected:
- it will provide greater convenience to the public as they will not need to carry a separate ID card and a plastic library card at the same time when using library services;
  - it will save administrative effort involved in the replacement of library cards as it is expected that the public would keep the smart ID card under safe custody; and
  - it will achieve cost saving due to the reduction in issuing plastic library cards for new patrons as it is expected that new patrons would prefer to use smart ID cards for library services.
- (d) The library automation system will provide detailed statistics of the issue and usage of the smart ID cards for monitoring by library staff. A full scale review of the service will be conducted one year after its implementation.

Reply :

- (a) The Leisure and Cultural Services Department at present contracts out cleansing, horticultural maintenance, landscaping work, and security guard services of many leisure facilities including indoor games halls; tennis courts; sports grounds, outdoor stadia; swimming pools; beaches; golf centers; water sports centers; holiday camps; parks and playgrounds. We have also contracted out the management services of indoor games halls; maintenance and inspection of shark prevention nets and beach rafts; and maintenance of play equipment in parks and playgrounds, etc.

- (b) The estimated expenditure on the outsourced services in 2002-03 is about \$508 million, of which \$231 million is for cleansing and supporting services; \$113 million for horticultural maintenance and landscaping work; \$68 million for security guard services; \$28 million for management services of indoor games halls; and \$68 million for other outsourcing services.
- (c) It is expected that the quality of services will be enhanced in terms of customer satisfaction and utilisation of facilities with an estimated cost saving of 40% in 2002-03 if the selected services are provided by contractors instead of in-house staff. A total of 345 posts will be deleted in 2002-03. This will not however result in any staff redundancy because the post holders have subscribed to the Voluntary Retirement Scheme and either have left or are leaving the service. Those who are not retiring will be redeployed to fill other vacancies in the department upon deletion of their posts.
- (d) The Department has kept under review the outsourced services and plans to further outsource electrical and mechanical services in Yuen Long and North Districts, and electronic payment system for collection of admission fees at swimming pools.

(d) To offer a balanced cultural programme, the Department's existing practice is to present one to two Western opera productions every year. These include one local production with overseas participation with a view to enabling local artists to widen their experience by working with internationally known artists, and to building up a core of local artistic and production personnel for the future. In 2002-03, the estimated provision for the local opera production, to be held in September, is \$3 to 4m. Based on past experience, around 20% is budgeted for performance fee and logistical expenses for overseas artists; 50% for local artists, orchestral accompaniment and production team; and 30% for sets, costumes and supporting services. The opera production will be publicized as a presentation of the Leisure and Cultural Services Department. The estimated rate of cost recovery through ticket sales is 50% based on direct production and marketing costs and the estimated number of paid audience of 8 000. Free arts appreciation activities such as talks and exhibitions relating to the production will also be organized.

(e) In 2002-03, the estimated provision for subventing the 4 performing companies is as follows:

The department does not normally specify the number of staff to be employed in the contracts. From returns provided by the contractors, however, a total of about 6 000 staff are employed under these contracts. The normal contract period varies from two to three years and the total contract value as at 1.12.2001 amounts to \$1,509 million. Details on the contracting out of various leisure and cultural services are at **Annex B**.

(b) There are a total of 17 posts in the department engaged in contract management duties, including formulation of contract management policy and practices, handling of tender and contract matters, alignment and standardization of contract terms and conditions, development of guidelines and systems for contract management and supervision of contractors. The total annual expenditure on salary amounts to \$6.3 million. In addition to the 17 dedicated posts, our front-line staff are also involved in the supervision and monitoring of contractors' performance.

- (b) Our District Social Welfare Officers concerned have collaborated with welfare services units of the Department and NGOs as well as other government departments to ensure the welfare needs in the affected areas will be met by substitute/replacement service after termination or downsizing of the NLCDPs.

Question : Regarding the expenses on the installation of golf net under Subhead 3201RS, please provide data on the expenses on similar projects carried out in the past and explain why there is a need to use the relevant funding for the provision of the facility.

Reply : The installation of a golf net 53 metres in height at the Golf Driving Range in Tuen Mun Recreation and Sports Centre (TMRSC) at the cost of \$44 million is the first project of this scale undertaken by the department. There is another project of a lesser scale at the Kwai Chung Wo Yi Hop Road Sports Ground where a golf net 20 metres in height at a cost of \$4.5 million was installed in 1995.

The Golf Driving Range in TMRSC is the first public golf centre in Hong Kong. The entire project was funded and developed by the then Royal Hong Kong Jockey Club (RHKJC). The then Regional Services Department was responsible for the management of the facilities up to 31.12.99 when the two ex-Provisional Councils were dissolved. Since then, the Leisure and Cultural Services Department has taken over the management role.

When the project was under planning in 1992, RHKJC and the then Regional Council were aware that the western portion of the Golf Driving Range within the site would be delineated for construction of a new road, now named as the Foothills Bypass, which was under planning concurrently by the Territories Development Department (TDD).

As the proposed highway project would not commence in five years' time, the road reserve area which would be resumed for road works was granted at that time to the Council for development and operation of a golf driving range under a temporary land allocation agreement. The TMRSC project, completed in February 1995, has since been opened for public use.

As the boundary of the Golf Driving Range was realigned so that the road reserve area of about 16,000m<sup>2</sup> could be returned to TDD, the length of the driving bays was curtailed by about 70 metres to 120 metres. While this would not affect golfing activity, to prevent swaying golf balls from spilling onto the Foothills Bypass, it was necessary to install a golf net surrounding the recessed boundary of the driving range.
