Question :

- (a) What is the total expenditure for providing access to IT facilities to all civil servants to promote greater use of IT for internal operations, and what are the specific contents of such programme?
- (b) What is the total expenditure for carrying out 80% of government procurement tenders through electronic means, and what sorts of procurement tenders would constitute the remaining 20%?

Asked by : Hon. CHAN Kwok-keung

Reply :

- (a) At present, IT facilities are provided to officers at Master Pay Scale Point 34 or above and to all grades of officers with an operational need, on an one-to-one basis. By enabling access to departmental business systems; internal communication through a government-wide networks; and providing external communication with the public through the Internet, the facilities help enhance efficiency of internal operation. We now plan to extend the provision of IT facilities to all the remaining officers of all grades, on a shared basis, to promote greater use of IT for internal operations.

We will implement a pilot project in about 14 bureaux and departments in 2002-03. The estimated non-recurrent cost of the pilot project is \$17m (average cost per bureau/department is \$1.2m) which will be provided under Capital Works Reserve Fund Head 710 - Computerisation. Depending on the result of the pilot, we will decide whether, when and how to extend the programme to other bureaux and departments.

- (b) Electronic procurement is an important initiative in driving the adoption of e-business in the private sector. We have set a target to carry out 80% of Government procurement tenders through electronic means by end-2003.

In order to meet our target, an Electronic Tendering System (ETS) has been in use by the Government Supplies Department for tendering non-works tenders since April 2000. As one of the world's first government tendering systems, the ETS allows suppliers from all over the world to receive notification of tenders, submit tender offers and receive notification of tender awards through the Internet. The cost for developing this system was \$8.4 m.

Apart from this, the Government already issues works tenders and receives tender proposals through CD-ROM. The Government also disseminates works tenders through the Internet. In 2002, the Works Bureau will complete a study on the feasibility of submission of works tenders through the Internet, which will give an indication of the cost for taking forward such initiative.

We have confidence in achieving the target of 80% by end of 2003. The remaining 20% relates to more complicated procurement tenders which are not appropriate for conducting electronically at this stage.

Question : Regarding the joint task force on e-business cooperation set up with the Government of the Guangdong Province, what is the total expenditure so involved, and what is the work of the task force ?

Asked by : Hon. CHAN Kwok-keung

Reply :

The work of the joint task force on e-business cooperation that we set up with the Government of the Guangdong Province is to explore and promote the cooperation on e-business and cross-certification between Guangdong Province and Hong Kong through the collaboration of both governments.

The task force held a meeting last December to discuss and exchange experience in the formulation of e-business legislation, the management of certification authorities and protection of consumer interest online. With the support and facilitation of the task force, the Hongkong Post Certification Authority and Guangdong Electronic Certification Authority have reached consensus on the mode of cooperation between the certification authorities of both places. The two parties are going to sign a cooperation document this month with a view to formulating a set of common certification policy and procedures for cross-certification. This will facilitate the development of cross-border e-commerce. In addition, the task force is now studying and planning other activities to promote the development of e-business in both places.

The expenditure incurred by the Information Technology and Broadcasting Bureau (ITBB) in the activities of the task force has yet to be confirmed pending the formulation of specific programmes. The funds payable by the Hong Kong side will be met with the provision under the "General departmental expenses" of ITBB.

Question : Regarding the provision of more online public services, whether there will be any impact on the civil service establishment after the programme is implemented? If yes, what are the implications?

Asked by : Hon. CHAN Kwok-keung

Reply :

The provision of more online public services provides an option for the public to obtain Government information and services through electronic means. While we aim to make such provision as attractive as possible, we have no immediate plans to reduce the provision of services through other conventional means, e.g. over the counter. Thus, we do not expect to see substantial impact on the civil service establishment in the near term solely arising from the provision of online services. But where the online service proves highly popular, there will be a case for reviewing the number of staff involved in providing the conventional means of the service, and hence possible savings in posts.

The general use of IT for internal Government operations may lead to staff savings through streamlining processes and increasing efficiency; and allow for better use and redeployment of staff providing more value added services for the public.

Question : One of the key tasks in 2002-03 is "organizing activities to help facilitate film financing". Please give details and the estimated expenditure of the programmes concerned.

Asked by : Hon. CHENG Kar-foo, Andrew

Reply :

To assist the film industry in film financing, Information Technology and Broadcasting Bureau and Television and Entertainment Licensing Authority jointly organized a symposium with the industry in late 2001. Overseas film financing experts were invited to attend the symposium to introduce different film financing systems in operation elsewhere in the world (including the completion bond system) to the local banking sector and film-makers. The feasibility of introducing similar systems to Hong Kong was also explored. One American completion bond company has already set up its office in Hong Kong after the symposium. We will continue to arrange specific follow-up activities, including the organization of thematic workshops on film financing in 2002-03 to cover accounting and the completion bond system for film-making, etc. The estimated expenditure of the concerned activities in 2002-03 is around \$200,000.

Reply :

In 2002-03, Information Technology and Broadcasting Bureau and Television and Entertainment Licensing Authority will organize a number of activities to facilitate film financing, including the organization of thematic workshops on film financing to cover the accounting system and the completion bond system for film-making. Expenditure of the activities concerned in 2002-03 is estimated to be around \$200,000. Through these activities, we hope to enhance the industry's understanding of film financing and encourage completion bond companies to take part in film financing activities in Hong Kong. One American completion bond company has already setup an office in Hong Kong to provide completion bond services. As film financing is a business decision between film-makers and financiers, we have not estimated the amount of fund that can be raised.

Reply :

The deletion of one directorate post in 2002-03 reflects a net position. It takes account of the creation of one post and the deletion of two. The creation of a supernumerary directorate post of Administrative Officer Staff Grade B (D3) for a period of two and a half years to drive the E-government initiatives was approved by the Finance Committee at its meeting held on 1 February 2002. Two supernumerary directorate posts, namely 1 Administrative Officer Staff Grade B (D3) and 1 Chief Engineer (D1), which were created to monitor the Cyberport project for a period of 3 years, will lapse in July 2002. Thus the net effect is a reduction of one directorate post during 2002-03. We will shortly consult the Legislative Council Panel on Information Technology and Broadcasting on the staffing of the Cyberport Division, in the context of the institutional arrangements for the future management of the Cyberport.

(a) What specific measures would the Information Technology & Broadcasting Bureau adopt in 2002-03 to “actively help the IT industry explore markets outside Hong Kong”?

(b) When would the aforesaid measures be implemented and how much resource would be deployed?

Asked by : Hon. SIN Chung-kai

Reply :

- (a) To help the local IT industry explore markets outside Hong Kong, we are exploring with the Hong Kong Trade Development Council disseminating, through the latter's web site, more information on the IT markets in the Mainland and other countries/territories, including tender information on government IT projects. In addition, we will organise in 2002-03 large-scale IT activities such as the ITU TELECOM Asia 2002 and Hong Kong Information Infrastructure Exposition and Conference 2003, to enable local IT companies to establish contacts with overseas business partners and to explore new business opportunities. The Information Technology and Broadcasting Bureau and Information Technology Services Department will lead delegations comprising local IT companies to participate in major IT events in the Mainland and other economies to promote the local IT industry and assist local IT companies to explore business opportunities. We are also committed to strengthening cooperation and exchange with the 9 countries (namely Canada, Australia, the United Kingdom, Finland, Israel, India, Republic of Korea, Germany and France) with which we have signed agreements on IT cooperation, in order to help the local industry tap these markets. For instance, the Government intends to lead an IT delegation to visit Finland in May 2002 and to lead another delegation to participate in Softworld 2002 to be held in Canada in September 2002.

In addition, we are also establishing a web site dedicated to promoting outstanding local IT products and services, in order to publicise abroad the achievements of the local IT industry.

- (b) Expenditure for implementing the aforesaid measures to help the local IT industry explore markets outside Hong Kong (including the organisation of and participation in various exhibitions and the arrangement of overseas visits) is estimated to be about \$14 m.

By enabling access to departmental business systems; providing internal communication through a government-wide network; and providing external communication with the public through the Internet, the facilities help enhance efficiency of internal operation. We now plan to extend the provision of IT facilities to all the remaining officers of all grades, on a shared basis, to promote greater use of IT for internal operations.

We will implement a pilot project in about 14 bureaux and departments in 2002-03. The estimated non-recurrent cost of the pilot project is \$17m (average cost per bureau/department is \$1.2m) which will be provided under Capital Works Reserve Fund Head 710 - Computerisation. Depending on the result of the pilot, we will decide whether, when and how to extend the programme to other bureaux and departments.

Reply: (a) The reference in the printed estimates to two Information Systems Strategy Studies/Reviews, 38 feasibility studies and implementation of 169 computer applications refers to numerous projects that individual bureaux/departments (including ITSD itself) will have undertaken in 2001-02 with ITSD support and assistance, under the Capital Works Reserve Fund Head 710 - Computerisation. The total financial provision involved is \$864m (inclusive of expenditure on IT contract staff) and 51 man-years of ITSD professional staff effort.

The useful life of new computer applications is normally taken to be 5 to 7 years for cost/benefit analysis purposes, although this will not become the upper limit for the serviceable life of all computer applications. When we design the applications, suitable room for expansion will be reserved so that the capacity of the system can be enhanced according to the ongoing business requirements. As regards the selection of software and hardware, we adopt products that operate on open platform as far as possible so that we can have wider choice in case of upgrades or replacement of the systems in future. This will help extend the serviceable life of the computer applications and their cost effectiveness.

- (b) In 2002-03, ITSD will invest \$39m in purchasing computer software and hardware. We give due consideration to operational needs and will consider redeploying existing hardware and software before procuring or replacing hardware and software; in so doing we can extend the serviceable life of existing equipment and achieve economy of resources and cost-effectiveness. We procure our hardware and software in accordance with government procurement regulations, through existing Government Supplies Department bulk supply term contracts. These contracts are established through open tendering. In these procurements, we require the contractors to supply products which have identifiable sources and are properly licensed and to provide adequate local support where applicable.

Reply: The preparatory work for the "Information Technology Professional Services Arrangement" (ITPSA) is in progress. This is an outsourcing arrangement for the supply of four categories of IT professional services, namely, (a) general information system development and maintenance, (b) web publishing system, (c) office systems and network, and (d) IT security services. ITSD is in the process of selecting 6 to 8 contractors for each category of service through open tender. Upon the conclusion of contracts, the selected contractors will be entitled to bid for IT projects under this arrangement during the ensuing 30 to 48 months.

This outsourcing arrangement will increase substantially the number of contractors and service categories. It will enhance the Government's access to IT human resources in the market, thereby increasing its capacity to develop IT systems and adopt IT solutions. Through the use of the ITPSA, government departments can commence IT project implementation with a shorter lead time after securing funding approval.

The purpose of the ITPSA is to provide IT professional services and human resources. It is estimated that government departments can acquire about 4 800 man-months in professional services (around \$270m in value) through this arrangement during the first year of operation of the ITPSA.

Regarding the evaluation of the effectiveness of the ITPSA, the selected contractors for the respective service categories will have to undergo competitive bidding for every IT project of that category. The ceiling unit prices of each service category will be stipulated in each individual contract. The government departments concerned will oversee the implementation of each IT project and will assess the performance of the contractor for reference by ITSD. ITSD will also monitor the overall performance of the contractors to ensure that cost-effectiveness is achieved through the ITPSA.

In 2002-03, ITSD will conduct a comprehensive review of the arrangements for the existing departmental application maintenance outsourcing services including the performance of the contractors. ITSD will then decide if the arrangement is to be continued or extended further.

To ensure that the services provided by the maintenance services contractors meet the requirements of ITSD, detailed service level benchmarks and assessment criteria have been stipulated in the contracts. Reply: To co-ordinate the development and implementation of Multi-Application Smart ID Card (MASC), it is planned that two posts including a Senior Systems Manager and a Systems Manager will be created in ITSD in 2002-03. Their duties are to participate in the design, development and support of the MASC Programme to ensure that the system is reliable and can operate smoothly in conjunction with other existing systems. They will also have to liaise with the participating departments, analyse their system requirements, design various common infrastructure, handle the procurement of the necessary products and services, manage the outsourcing of contracts, and monitor the performance of the contractors, etc.

There will be four value-added applications on the smart identity card including digital certificate, library card, change of address and driving licence. All four applications will be optional to the identity card holders who may choose to use any or all applications according to their own needs. With the exception of the driving licence which will become available in 2005-06 when the relevant systems are ready, citizens will be able to enjoy the convenience brought by the other three applications as soon as the Identity Card Re-issue Exercise commences in mid 2003.

- Digital Certificate The cardholders may choose to accept a free digital certificate valid for one year issued by the Hongkong Post (HK Post) Certification Authority when they apply for their new smart identity cards. The digital certificates will have been embedded in the new smart identity cards at the time of issuance.
- Library Card The cardholders will be able to use their new smart identity cards as library cards to access the services and facilities in the public libraries.
- Change of Address With the digital certificate embedded onto the smart identity

cards, the cardholders can do online change of address using one form for four government departments/offices (namely Transport Department, Inland Revenue Department, Rating and Valuation Department, as well as the Registration and Electoral Office).

- Driving Licence From 2005-06 onwards, the smart identity cards will allow the holders to check their driving licence particulars stored in the back-end computer system of the Transport Department. With the smart identity card, licensed drivers can also drive without carrying their driving licences with them.

As for the resources involved, for the digital certificate and library card applications, upgrading of back-end computer systems in HK Post and Leisure and Cultural Services Department will be required. The upgrading will be at a one-off non-recurrent cost of less than \$10 million each. These will be met under the Computerisation Block Vote of the Capital Works Reserve Fund. HK Post will absorb the recurrent costs for giving out free e-Certs. For the implementation of the driving licence application, the majority of the cost will be incurred in the context of the development of Transport Department's Vehicles and Drivers Licensing Integrated Data System IV (VALID IV) and Police's Command and Control Communications System III (CCIII). We do not envisage any significant additional cost over that already envisaged.

Reply:

RTHK attaches great importance to “advice on radio reception” and “follow-up action on calls to public affairs programming”. The “10 working days” target has been set according to operational needs and resource allocation constraints.

As regards “advice on radio reception”, the duty engineers, upon receipt of an enquiry, will contact the caller immediately and provide the necessary assistance. RTHK launched the “Easy Reception” campaign last December, and over 800 enquiries were received with more than 80% of them satisfactorily resolved within 7 days. Accordingly, RTHK will consider reducing the “10 working days” radio reception service target.

As for public affairs programming, the producers, upon receiving a complaint, often have to liaise with relevant departments or organizations. The complainant will be notified after a solid reply is obtained. The follow-up process usually involves liaison and research with outside parties, thus the 10-day period is considered reasonable.

Work on RTHK's 5-year strategic plan and development of Key Performance Indicators (KPIs) was funded through the redeployment of resources within this financial year. A consultancy firm was appointed in October 2001 at a cost of \$0.82 m. It undertook research through staff focus group discussions (involving around 170 programme officer grade staff) and senior executive workshops (involving 25 senior staff, including directorate) The study helped compile future strategies and goals (e.g. outsourcing and employing non-civil service contract staff) along with a set of KPIs suitable for measuring the performance of public broadcasting services, including cost efficiency indicators.

The plan covered:

- fine-tuning RTHK's SWOT (Strengths, Weaknesses, Opportunities and Threats) analysis;
- identifying options for principal Strategies, Goals and KPIs;
- outlining a higher level Manpower Plan showing "best practice options" e.g. the benefits of more flexible staffing arrangements employed by other public broadcasters;
- seeking RTHK staff's views on KPIs, training, job enrichment and balance of staff mix required to drive the strategic plan.

The exercise is nearing completion and a draft final report is expected by the end of this month.

The study has not included the issue of RTHK corporatisation.

As the study mainly focused on personnel, resource allocation and cost efficiency, the Government will not conduct any public consultations.

Reply:

In 2002, RTHK will collaborate with the Hong Kong Arts Development Council, Leisure and Cultural Services Department (LCSD), and Television and Entertainment Licensing Authority (TELA) to produce a wide range of cultural and arts programmes. These include 6 episodes of an art education series "*Arts Unlimited*", 26 episodes of local art and artists series "*Artist Profiles*", 8 episodes of a museum and art museum series (jointly produced with the LCSD), and 8 episodes of "*8 Beats*" featuring overseas and local animation productions. To promote the local film industry, RTHK, together with TELA, will produce 4 episodes of "*Film Industry*".

As regards classical music and arts performances, RTHK has already broadcast live, during TV prime-time, "*Yundi Li & the Hong Kong Philharmonic Orchestra Live*" and "*Yo Yo MA & the Hong Kong Philharmonic Orchestra Live*". Both programmes were well received by the audience. RTHK will continue to collaborate with LCSD, the Hong Kong Philharmonic Orchestra and other organizations such as the Hong Kong Arts Festival to broadcast live/relay 8 concerts and art performances.

The total output of art and cultural programmes in 2002 will amount to 32.2 hours, and the estimated production cost of these programmes is \$8.43 m.

In 2002-03, we plan to delete a total of 16 posts, including 2 Personal Secretary IIs, 4 Office Assistants, 1 Calligraphist, 3 Assistant Clerical Officers, 1 Clerical Assistant and 5 Senior Foremen. As we also plan to create 4 new posts, the net number of post deleted is therefore 12. Based on the notional annual mid-point salary values of the 16 deleted posts, the total salary involved is \$2.816 m.

In order to ensure that the deletion of above posts will not compromise the quality of our services, the department has reviewed and streamlined existing working procedures, re-engineered and arranged for outsourcing of dispatch service, provided existing staff with appropriate training and equipment needed for office automation. All these measures aim to reduce reliance on clerical and secretarial services and to achieve a higher level of efficiency through the wider use of information technology and enhanced productivity measures. Meanwhile, we will closely monitor the cost-effectiveness of our outsourcing arrangement.

In the case of electronic media, if it is detected that television programme service or sound broadcasting service licensees have transmitted content of an obscene nature, TELA will take regulatory action in accordance with the statutory procedures, the relevant legislative provisions and licence conditions as well as the programme and advertising standards set out in Codes of Practices. Funding required in this regard is already included in the Estimates for the Broadcast Monitoring and Regulation Programme. As regards the transmission of obscene materials through the Internet, it comes under the ambit of the Control of Obscene and Indecent Articles Ordinance and is subject to regulatory control under the "Code of Practice: Practice Statement on Regulation of Obscene and Indecent Material" developed by the Government and the Hong Kong Internet Services Providers Association in 1997. No additional funding is required for carrying out this area of work.

Reply:

In 2002-03, TELA has earmarked a provision of some \$2.5 m. for organising publicity activities to promote the COIAO. The target of these activities will include young people, parents, teachers and the general public. These include training on the installation and use of filtering software, seminars, and promotional activities on the importance of parental guidance through the newly set up Healthy Information Resource Centre (with a budget of about \$0.2 m); producing an API for television broadcast (about \$0.4 m); organizing the Ten Healthy Website Competition (about \$0.5 m) and implementing the COIAO Publicity Activities Funding Scheme (about \$1.2 m). Moreover, around \$0.2 m will be allocated for organizing activities for the young cyber ambassadors trained under the Cyber Ambassador Awards Scheme. It is hoped that through the above activities, we will be able to enhance young people's understanding of the importance of choosing healthy reading materials and arouse the concern of parents, teachers and members of the public on the adverse effect of obscene and indecent articles on young people.

(a) In 2001-02, the Film Development Fund (FDF) allocated a total of \$5.6 m to promote Hong Kong films overseas. Among the disbursements, \$4.7 m were used to fund the "Hong Kong at Cannes" held during the Cannes International Film Festival and \$0.9 m were used to sponsor the participation of 10 Hong Kong films in 7 overseas film festivals. As regards the expenditure committed by the Trade Development Council and the Hong Kong Tourism Board for the purpose of promoting Hong Kong films, they are not expenditure items under Head 180.

(b) TELA has no plan to organize promotional activities similar to the "Hong Kong at Cannes" at international film festivals or other forum in 2002-03. However, the FDF will continue to provide funding support to promote Hong Kong films, such as sponsoring the participation of Hong Kong films in overseas film festivals. TELA will also assist the HKSARG Offices outside Hong Kong in the organisation of overseas Hong Kong Film Festivals. Activities of this nature do not require additional funding under Head 180.
