**I. SUMMARY**

## **II. REPORT**

### **Object of the Bill**

To adapt certain Ordinances and subsidiary legislation to bring them into conformity with the Basic Law and with the status of Hong Kong as a Special Administrative Region of the People's Republic of China.

### **Date of First Reading**

3. 17 May 2002.

### **Comments**

4. A list of the Ordinances affected by the proposed amendments in the Bill and a summary of the amendments are set out in Annexes A and B respectively. The proposed amendments are essentially technical changes to individual Ordinances.

5. The proposed amendments in the Bill are along the same lines as amendments proposed in other Adaptation of Laws Bills which have been passed by the Legislative Council.

6. If enacted, those provisions which existed immediately before 1 July 1997 shall, subject to Article 12 of the Hong Kong Bill of Rights, take effect retrospectively as from 1 July 1997. In other words, the retrospective effect will not apply to provisions involving criminal offences or penalties. For provisions which were enacted on or after 1 July 1997, the Bill provides that the relevant adaptations shall take effect on the dates on which the respective provisions were enacted.

### **Public consultation**

7. The Administration considers that the proposed amendments are essentially straightforward editorial adaptations, hence public consultation is not necessary (para. 16 of LegCo Brief).

### **Consultation with LegCo Panels/Committees**

8. Proposals in the Bill have not been referred to any LegCo Panels or Committees.

### **Conclusion**

9. The legal and drafting aspects of the Bill are in order. Subject to Members' views, the Bill is ready for resumption of Second Reading debate.
