Government's Legislative Programme for 2001 - 2002

I enclose, at Annex, an indicative list of bills which the Administration intends to introduce into the Legislative Council in the current legislative session.

As the Chief Secretary for Administration has pointed out in the Administration's response to the debate on the Motion of Thanks on 24 October 2001, we have taken a fresh and critical look at our Legislative Programme in an attempt to ease Members' workload in scrutinizing government bills. The enclosed list represents the outcome of these conscious efforts. We hope that, by seeking to introduce only the most essential bills into the Legislative Council, we would facilitate Members in performing their important function of enacting laws for Hong Kong.

As to individual bills, you would appreciate that we cannot be more specific at this stage regarding the timing and details since they are, amongst other things, subject to the Executive Council's consideration and approval. We shall inform Members of the first reading dates and other details as soon as we are in a position to do so.

While we would make every effort to adhere to the Legislative Programme, the enclosed list may need to be adjusted in the course of the legislative session. There could be cases where the Administration needs to introduce bills not on the enclosed list due to unforeseen circumstances, or instances where bills on the list might not be introduced under the current estimated timeframe. As previously agreed with the Legislative Council, we will update the Legislative Programme more frequently in light of major changes.

I hope this indicative list would be useful to Members for planning their legislative work.
