**Resolution Under Section 54A of the  
Interpretation and General Clauses Ordinance (Cap. 1)**

**Transfer of Statutory Functions  
from Secretary for Transport  
to Secretary for Transport and Works**

**Introduction**

This paper sets out the transfer of statutory functions currently exercisable by the Secretary for Transport to the Secretary for Transport and Works with effect from 1 July 2002.

**The Resolution**

2. The introduction of the accountability system will be accompanied by the reorganization of a number of policy bureaux. As a result, the Secretary for Transport and Works will be responsible for matters relating to transport and works. The relevant statutory functions currently vested in the Secretary for Works and the Secretary for Transport will be transferred to the Secretary for Transport and Works.

3. Paragraph 12(a) of the draft Resolution provides that statutory functions currently exercisable by the Secretary for Transport by virtue of the ordinances specified in column 2 of Schedule 12 to the Resolution be transferred to the Secretary for Transport and Works. To give full effect to the Resolution, incidental, consequential and supplemental amendments, as appropriate, are introduced. Such amendments are provided for in paragraph 12(b) and Schedule 12 of the draft Resolution. Most of the amendments are to replace references to “Secretary for Works” in the relevant ordinances with references to “Secretary for Transport and Works”. Paragraph 12 and Schedule 12 of the draft Resolution are attached at Annexes A and B respectively.

4. The opportunity is also taken to improve the definition clauses of some ordinances. For example, in three ordinances (the Eastern Harbour Crossing Ordinance, the Tate's Cairn Tunnel Ordinance, Western Harbour Crossing Ordinance), the definition of "Secretary" is only provided for in the English text. A corresponding definition would be added to the Chinese text.

5. A summary of the major statutory functions of the Secretary for Transport under existing legislation and the textual amendments to the relevant ordinances is attached as Annex C.

6. Members are invited to consider paragraph 12 and Schedule 12 of the draft Resolution.
