

**Subcommittee to Study the Proposed  
Accountability System for Principal Officials and Related Issues**

**Amendments to the Draft Resolution under Section 54A  
of the Interpretation and General Clauses Ordinance (Cap. 1)**

**Introduction**

This paper seeks to inform members of the amendments made to the draft Resolution which was issued to the Legislative Council on 17 April 2002.

**Background**

2. The Resolution to effect the necessary transfer of statutory functions arising from the re-organization of certain bureaux was presented to the Legislative Council, in draft form, on 17 April 2002. Certain amendments to the draft Resolution have been made since then. These are summarized in the following paragraphs. Formal notice on the revised Resolution was issued to the Legislative Council on 1 June 2002.

**Changes made to the draft Resolution**

3. Major changes made to the previous draft Resolution are: -
- (a) changes arising from the adjustment to the distribution of portfolios of the policy bureaux; and
  - (b) technical amendments.

***Adjustments to the portfolios of the policy bureaux***

4. In the light of the views of the public and the discussion at this Subcommittee, the Administration has decided to adjust the portfolios of the policy bureaux and the draft Resolution has been

amended accordingly:

- (a) relevant statutory functions relating to the “environment” portfolio currently exercisable by the Secretary for the Environment and Food will be transferred to the future Secretary for the Environment, Transport and Works;
- (b) relevant statutory functions relating to the “food and environmental hygiene” portfolio currently exercisable by the Secretary for the Environment and Food will be transferred to the Secretary for Health, Welfare and Food;
- (c) relevant statutory functions relating to the “labour” portfolio currently exercisable by the Secretary for Education and Manpower will be transferred to the Secretary for Economic Development and Labour;
- (d) statutory functions relating to manpower development, including training and retraining of the workforce will remain with the Secretary for Education and Manpower; and
- (e) relevant statutory functions currently exercisable by the Secretary for Commerce and Industry and the Secretary for Information Technology and Broadcasting will be transferred to the future Secretary for Commerce, Industry and Technology.

A revised list of the titles of the bureau secretaries under the accountability system is enclosed at Annex A. A comparison of the draft Resolution and the revised Resolution in this respect is attached at Annex B for members’ reference.

### ***Technical Amendments***

5. We have also made a number of technical amendments to the draft Resolution, which include the following: -

- (a) provisions added to cover legislation enacted since the previous draft Resolution was presented to the Legislative

Council; and

- (b) changes made to better reflect the policy intent of the relevant provisions. For example, the words “as provided for by the amendments made under subparagraph (b)” in each subparagraph (a) of paragraph (1) to (13) are deleted. This puts beyond doubt that the statutory functions are transferred on an Ordinance basis.
