## **I. Election of Chairman**

### Election of Chairman

Mr Kenneth TING was elected Chairman of the Subcommittee.

2. The Subcommittee noted that the House Committee had referred the following two Commencement Notices to the Subcommittee:

(L.N. 256 of 2001 gazetted on 30 November 2001)

3. The Subcommittee deliberated (Index of proceedings attached at **Appendix**).

4. The Subcommittee was pleased to note from the representative of the Customs and Excise Dutiable Commodities Customer Liaison Group that the trade's three major concerns about the introduction of the electronic data interchange (EDI) service to process dutiable commodities permits (DCPs) had been addressed by the Administration and the Tradelink Electronic Commerce Ltd. Whilst supporting in

principle the launch of the EDI service in January 2002, the Subcommittee requested the Administration to further examine the following issues:

- (a) New Regulation 22(6)
  - (i) To amend Regulation 22(6) to limit the power of the Commissioner of Customs and Excise to specify applications for DCPs to be submitted in paper form so as to ensure that the power would only be exercised where necessary, e.g. by specifying the circumstances under which the power was to be exercised, or by specifying where it was not practicable to submit applications in electronic form for a limited period; and
  - (ii) To clarify whether there is a need for an express power to specify when the period for reversion to paper form would end.
  
- (b) New Regulation 106
  - (i) To review Regulation 106 to ensure that the drafting was consistent with other transitional provisions and the approach was consistent with other legislation, such as that for import and export declarations in the Import and Export (Registration) (Amendment) Regulation 1999 (L.N. 322 of 1999); and
  - (ii) To consider specifying the end date of the transitional period to provide certainty to all relevant parties, in particular the inactive or new users of the EDI service.

5. To allow time for the Subcommittee to scrutinize the Regulation, the Subcommittee agreed that the Chairman should move a motion at the Council meeting on 19 December 2001 to extend the scrutiny period of the Regulation and the two Commencement Notices mentioned in paragraph 2 above to 9 January 2002. The deadline for giving notice of amendments was 2 January 2002.

6. The Chairman would make a verbal report to the House Committee on 14 December 2001, to be followed by a written report on 4 January 2002.

7. The Subcommittee agreed to hold the next meeting on Thursday, 20 December 2001, at 2:30 pm.

*(Post-meeting note: With the concurrence of the Chairman, the starting time of the next meeting on 20 December 2001 was changed to 3:00 pm.)*
