#### I. Meeting with the Administration

[LC Paper No. CB(2)139/02-03(01)]

The Bills Committee deliberated on the further undertakings to be given by the Administration (Index of proceedings attached at **Annex**).

- 2. Mr LAU Kong-wah informed members that the Administration had given further undertakings to avoid imposing unnecessary administrative work on decent organisers of dance parties. In response to the Subcommittee's request, the Administration agreed to provide a written response before 30 October 2002 to confirm the following undertakings in respect of applications for a Place of Public Entertainment (PPE) licence for holding dance parties -
  - (a) when processing applications for PPE licences for holding dancing parties, the fire safety requirements for such activities would be similar to those currently required for other PPE licences, and existing building safety standards for permitting dance activities in other licensed premises would apply;
  - (b) if the premises which had already been issued with PPE licences were found suitable for holding dance parties, their licences could be amended to provide for holding dance parties in these premises

by way of payment of an amendment fee by the licencees to the Food and Environmental Hygiene Department in accordance with the Places Of Public Entertainment Regulation, and the amendment fee would be of a nominal nature; and

- (c) the Administration would review whether the validity period of a permanent PPE licence could be extended to at least 24 months and whether the discrepancy between the existing fees for the issue of an annual PPE licence in the urban and New Territories areas could be removed in one year's time.
- 3. The Chairman said that he supported the alternative arrangement proposed by the Administration to address members' concerns that the proposed Amendment Regulation might burden decent organisers of dance parties with unnecessary administrative work and cost. He also welcomed the further undertakings given by the Administration. Other members also had not expressed any objection to the Amendment Regulation and the Exemption Order. The Chairman said that he would give a verbal report on the deliberations of the Subcommittee on the proposed Amendment Regulation and Exemption Order at the House Committee meeting held at 2:30 pm on the same day. He also reminded members that the deadline for giving notice to move a motion to amend or repeal these two items of subsidiary legislation was 30 October 2002.

4. There being no other business, the meeting ended at 1:10 pm.
