**I. Meeting with the Administration**

(LC Paper Nos. CB(2)920/02-03(01) and (02) and LS45/02-03)

The Subcommittee deliberated (Index of proceedings at **Annex**).

2. The Administration was requested to re-consider the following issues raised by members at the meeting -

- (a) To provide to the Subcommittee the instruction by the Ministry of Foreign Affairs (MFA) of the People's Republic of China (PRC) to implement the United Nations Security Council Resolution (UNSCR) 1390 in the Hong Kong Special Administrative Region (HKSAR). If the answer was in the negative, to provide a written response on the legal basis or other principles justifying non-disclosure and a confirmation as to whether this was instructed by MFA; and
- (b) To clarify -
  - (i) whether the existing section 10 of the United Nations (Anti-Terrorism Measures) Ordinance could cover the requirement of UNSCR 1390 to prohibit the provision of technical advice, assistance or training related to military activities to terrorists; and
  - (ii) the amendment to that section to be proposed by the Administration, and in the light of the proposed amendment, the appropriateness of using that section to cover the requirement of UNSCR 1390 to prohibit the provision of technical advice, assistance or training related to military activities to terrorists.

Action

3. The Administration was also requested to provide a written response on the following issues raised by the members at the meeting -

- (a) The types of instructions received by the HKSAR Government from MFA, other than those on the implementation of UNSCRs, and the reason(s) why these instructions could not be released to Members of the Legislative Council (LegCo); and
- (b) An explanation on why the Administration considered it in order to repeal certain sections of the Afghanistan Regulation, given that the Chief Executive was required to make regulations to give effect to a relevant instruction from MFA of the PRC under section 3(1) of the United Nations Sanctions Ordinance (Cap. 537) (the Ordinance).

4. The Administration was invited to give their views on the comments made by the Legal Service Division of LegCo on the operation of the Ordinance set out in LC Paper No. LS 45/02-03. Specifically, whether the Administration would amend the Ordinance to extend its scope of coverage with regard to sanctions imposed by the United Nations Security Council and to provide for regulations made under section 3 to be vetted by LegCo.

**II. Date of next meeting**

5. Subject to confirmation from the Administration, the next meeting of the Subcommittee would be held on 13 February 2003 at 4:30 pm.
