Progress of Interconnection Issues and
Update on the Coverage of the Network and Services
of the Three New Wireline-based
Local Fixed Telecommunications Network Services Operators

Background

On 8 January 2001, the Panel was briefed of the issues relating to interconnection between local fixed networks. On 12 February 2001, the Panel was briefed of the coverage of the networks and services of the three new wireline-based local fixed telecommunications network services operators (new FTNS operators) up to the end of 2002. This paper gives an update on the progress of interconnection issues and the coverage of the FTNS operators.

Interconnection

2. The paper prepared for the Panel meeting on 8 January 2001 provided a list of the determinations for interconnection which had been completed by the Office of the Telecommunications Authority (OFTA) since July 1995 and a list of determination then in progress. The two lists are updated and attached to this paper in Annex 1.

Annex 1

Coverage

3. The commitments regarding the extension of network and services coverage made by the new FTNS operators, namely Hutchison Global Crossing Limited (HGC), Wharf New T & T Limited (New T & T) and New World Telephone Limited (NWT) under their respective Deeds of Undertakings to the Government are as follows:

- (a) network coverage through “Type II interconnection” to the local exchange of PCCW-HKT;
- (b) Provision of direct access to buildings; and
- (c) A minimum capital investment.

In addition to the commitments for 2002, the new FTNS operators have also laid down interim milestones for the years 2000 and 2001. The progress are set out at Annex 2.

Annex 2

4. Two of the operators have met the respective interim milestones made for 2000 and one of them even rolled out beyond the initial commitments. HGC did not complete the Type II interconnection in three local exchanges by end 2000. The TA requested HGC to take reasonable actions or remedies to fulfill the target set. HGC has since completed the Type II interconnection in two of the three exchanges and has limited coverage in one exchange.

5. Since 29 September 2001, OFTA has also published in its website (www.ofta.gov.hk) information supplied by the new FTNS operators relating to their network coverage. The lists of exchanges cover all the exchanges to which Type II interconnection have been made so far. OFTA will verify such commitments when undertaking the verification exercise at the year end.

6. Given that the milestones are not measured on the basis of network coverage in public housing estates, private residential premises and commercial premises, it is difficult to assess the respective network coverage of the new FTNS operators in public housing estates, private residential premises and commercial premises by district. However, it is stipulated in the licence conditions (i.e. General Condition (GC) 10(2)) that if an FTNS operator has access to the telephone exchange of a region or has direct connection to a particular building, it should provide services to customers of that region or occupants of that building. Also, it cannot refuse to provide services to customers of individual building (e.g. public housing estates). If there is infringement of the licence conditions, the Telecommunications Authority (TA) could take necessary action in accordance with the Telecommunications Ordinance.

7. With the number of the telephone exchanges and premises connected by the three operators up to September 2001 we estimate that currently more than 35% of residential customers can choose to subscribe to the services provided by one of the three new operators. Considering the current progress of network coverage, we believe that by the end of 2002, more than 50% of residential customers will have an alternative choice of at least one of the three new FTNS operators.

8. In terms of market share, we estimate that the three new operators currently have a market share of about 10%. We would however like to highlight that market share of the three new operators is a matter for the market which depends on, inter alia, customer preferences. Our aim is to provide alternative choices to consumers through competition in a liberalising market.

Safeguarding Fair Competition among the FTNS Operators

Improving productivity for local loop interconnection

9. In order to facilitate competition in the local telephone market, it is vital that PCCW-HKTC should provide an efficient service in the interconnection of local loops to the new FTNS operators. Having considered the representations made by PCCW-HKTC and the new FTNS operators, and having inspected locations where interconnection took place, the TA has formed the view that PCCW-HKTC should improve its productivity on the interconnection of local loops.

10. On 16 November 2001, the TA accepted the proposal of PCCW-HKTC to improve its productivity by deploying more resources and streamlining its process. The number of local loop interconnections will increase from 9 per 2-hour per operator per exchange to a maximum of 16, depending on the technical constraints in the telephone exchange concerned. The proposal will run for a trial period of six months from 2 January 2002, during which the TA will monitor the productivity and examine the demand from the new FTNS operators to see whether this improved productivity will meet the demand. At the end of the trial period, the TA will review the adequacy of the improved productivity.

Revising procedure for making determinations of interconnection

11. With a view to providing parties involved in an interconnection dispute with certainty as regards the timing required to complete the determination process, the TA on 27 September 2001 revised the procedure for making determinations on the terms and conditions of interconnection agreements. The revised procedure now specifies the time limit for each step in the determination process. According to the revised procedure, a normal case should be determined in less than 5 months while a complex case should be determined in 6½ months.
