Dear Mr. CHAN,

Yung Shue Wan Development, Engineering Works, Phase 2

Thank you for your letter on 26 July 2002 addressed to the Director of Planning concerning the proposed Phase 2 reclamation in Yung Shue Wan, Lamma Island.

For your information, the Civil Engineering Department (CED) is responsible for the design and implementation of the proposed engineering works for the reclamation and the infrastructure for the future development. The scope of the project includes :

- (1) Seawalls and reclamation of about 1ha of land;
- (2) An emergency vehicular access;
- (3) A seafront promenade;
- (4) Storm water drainage and sewerage; and
- (5) Associated landscaping works.

_____ A plan covering the proposed Phase 2 reclamation is attached.

On the planning aspects, at the first instance, I wish to clarify that the proposed project is a small-scale reclamation involving a strip of land of about 1 ha with the aim of improving Yung Shue Wan. The objectives of the Phase 2 reclamation are to alleviate the inadequate pedestrian space en route to the ferry pier, to provide an emergency vehicular access (EVA) connected to the proposed helipad for emergency purpose, to provide land to cope with the shortfall of the open space and community facilities provision in Yung Shue Wan, to provide small scale commercial development as a focal point, and to improve the waterfront of Yung Shue Wan for public enjoyment. In addition, the proposed Phase 2 reclamation would also provide the opportunity for improving stormwater and sewerage facilities at the locality.

We do appreciate your concerns on the possible loss of unique rural character as well as the design of the Phase 2 reclamation. In addition, the concerned Government departments would also critically review the design of Phase 2 reclamation and the proposed land uses on the reclaimed area to ensure the compatibility with the surrounding environment.

CED is now conducting an Environmental Impact Assessment (EIA) for the proposed reclamation. We and other concerned departments would consult the Legislative Council, the Islands District Council, the local community and concerned groups on the land use concept for the proposed Phase 2 reclamation after the EIA has been finalized later this year.

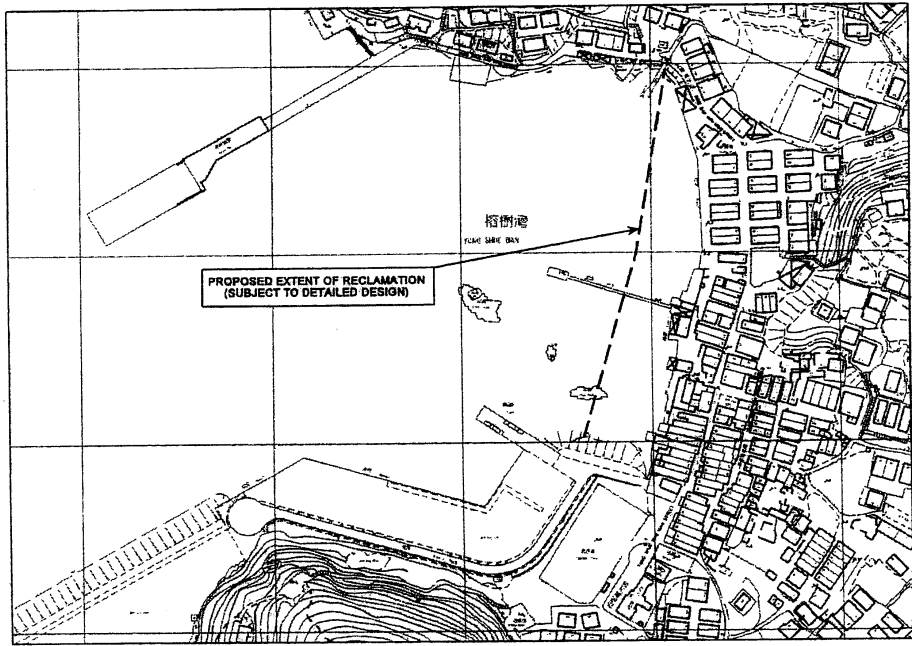
