INTRODUCTION

At the meeting of the Executive Council on 14 May 2002, the Council ADVISED and the Chief Executive ORDERED that –

- A
- (a) the Patents Ordinance (Amendment of Schedule 1) Order 2002 at Annex A, should be made under section 153 of the Patents Ordinance;
- B
- (b) the Trade Marks Ordinance (Amendment of Schedule) Order 2002 at Annex B, should be made under section 13A(7) of the Trade Marks Ordinance;
- C
- (c) the Registered Designs Ordinance (Amendment of Schedule) Regulation 2002 at Annex C, should be made under section 83 of the Registered Designs Ordinance; and
- D
- (d) the Layout-design (Topography) of Integrated Circuits (Designation of Qualifying Countries, Territories or Areas) Regulation at Annex D, should be made under section 24 of the Layout-design (Topography) of Integrated Circuits Ordinance,

to provide in the new Schedules the updated list of countries which have acceded to the Paris Convention for the Protection of Industrial Property and the countries, territories or areas which have acceded to the World Trade Organization Agreement.

BACKGROUND AND ARGUMENT

2. China is a party to the Paris Convention for the Protection of Industrial Property (the “Paris Convention”) and the Central People's Government (“CPG”) has applied the Paris Convention to the Hong Kong Special Administrative Region (“HKSAR”). HKSAR is required to seek the prior approval of CPG via the Office of the Commissioner of the Ministry of Foreign Affairs (“OCMFA”) in Hong Kong before amending

the list of countries which have acceded to the Paris Convention. HKSAR is a member in its own right of the World Trade Organisation (“WTO”).

3. Under the Paris Convention, HKSAR is obliged to grant to a person who has filed an application for registration of a patent, industrial design or trademark in a Paris Convention country a right of priority during a prescribed period for the purpose of filing the same application in HKSAR. Similarly, the Agreement on Trade-Related Aspects of Intellectual Property Rights (“TRIPS Agreement”) under the WTO obliges HKSAR to do the same in respect of an application filed in a WTO member country, territory or area.

4 To fulfill our international obligations, we have made specific provisions in the Patents Ordinance, the Trade Marks Ordinance and the Registered Designs Ordinance to the effect that a person who has filed an application in a Paris Convention country or WTO member country, territory or area will enjoy a right of priority. We have also set out in a Schedule in each of the Ordinances the list of Paris Convention countries and WTO member countries, territories or areas. The Chief Executive in Council is empowered to amend the Schedules to the Patents Ordinance and the Registered Designs Ordinance by an Order and Regulation published in the Gazette respectively. In the case of the Trade Marks Ordinance, the Chief Executive is empowered to amend the Schedule by an Order published in the Gazette.

5. The TRIPS Agreement also requires HKSAR to grant the same level of intellectual property protection for layout-designs (topographies) to citizens of other WTO member countries, territories or areas, as to HKSAR citizens. To meet our international obligations, we have provided in the Layout-design (Topography) of Integrated Circuits Ordinance that such protection will be given to such qualifying countries, territories or areas as are designated by the Chief Executive by Regulation. The Layout-design (Topography) of Integrated Circuits (Designation of Qualifying Countries, Territories or Areas) Regulation has been made for this purpose. In practice, we will include under this Regulation those countries, territories or areas that have acceded to the WTO.

THE NEED FOR UPDATING

6. Since the above-mentioned Schedules were last amended in 1998 and the Regulation was made in 1996, some countries, territories or areas have become members of the Paris Convention or WTO. Some existing Paris Convention countries have changed their names. As a result, we need to update the Schedules under the Ordinances and the Regulation concerned.

7. Schedule 1 to the Patents Ordinance contains two lists : (a) Paris Convention countries; and (b) WTO member countries, territories or areas which are not Paris Convention countries. As some countries in the latter list have now become members of the Paris Convention, it is necessary to move their names from the latter list to the former list. The same applies to the Schedule to the Registered Designs Ordinance.

8. The Schedule to the Trade Marks Ordinance contains a combined list of Paris Convention countries and WTO member countries, territories or areas. It is not necessary to change the list in the situation where a WTO member has become a Paris Convention member as in the cases of the Patents Ordinance or the Registered Designs Ordinance.

9. One country, Solomon Islands, already exists in the Schedules of the Patents Ordinance, the Registered Designs Ordinance and the Trade Marks Ordinance by virtue of its WTO membership. It has not yet been included in the Layout-design (Topography) of Integrated Circuits (Designation of Qualifying Countries, Territories or Areas) Regulation. Another country, Equatorial Guinea, already exists in the Schedules of the Patents Ordinance and the Registered Designs Ordinance by virtue of its Paris Convention membership. It has not yet been included in the Schedule of the Trade Marks Ordinance.

10. We have obtained the approval of CPG via OCMFA to amend the list of countries which have acceded to the Paris Convention.

11. We have also taken the opportunity to replace the names of the countries, territories and areas in the Schedules with full names in line with the record of OCMFA.

12. For easy reference, we have summarized the proposed amendments at Annex E .

THE ORDERS AND REGULATIONS

13. The Patents Ordinance (Amendment of Schedule 1) Order 2002 at Annex A, the Trade Marks Ordinance (Amendment of Schedule) Order 2002 at Annex B, the Registered Designs Ordinance (Amendment of Schedule) Regulation 2002 at Annex C and the Layout-design (Topography) of Integrated Circuits (Designation of Qualifying Countries, Territories or Areas) Regulation at Annex D repeal the existing Schedules and replace them with the updated list of countries in the new Schedules.

14. Copies of the relevant empowering provisions of the Ordinances and the relevant Schedules as well as the Regulation being amended are at Annexes F and G.

PUBLIC CONSULTATION

15. The proposed amendments are technical and minor in nature. No consultation is considered necessary.

BASIC LAW IMPLICATIONS

16. The Department of Justice advises that the proposed Orders and Regulations are consistent with the Basic Law.

HUMAN RIGHTS IMPLICATIONS

17. The Department of Justice advises that the proposed Orders and Regulations have no human rights implications.

BINDING EFFECT

18. The Department of Justice advises that the amendments will not affect the current binding effect of the principal Ordinances.

FINANCIAL AND STAFFING IMPLICATIONS

19. There is no financial or staffing implication arising from the Orders and Regulations.

ECONOMIC IMPLICATIONS

20. There is no economic implication arising from the Orders and Regulations.

LEGISLATIVE TIMETABLE

21. The Orders and Regulations will be published in Gazette on 17 May 2002 and tabled at the Legislative Council on 22 May 2002. The amendments will take effect on 11 July 2002 after the lapse of the negative vetting procedure.

PUBLICITY

22. A press release will be issued on 17 May and a spokesman will be available to handle enquiries.
