The Bills Committee deliberated (index of proceedings attached at **Annex**).

I. Election of Chairman and Deputy Chairman

- 2. Mr IP Kwok-him and Miss Margaret NG were respectively nominated by Mr YEUNG Yiu-chung and Mr Martin LEE as candidates for the Chairman of the Bills Committee.
- 3. <u>Mr CHEUNG Man-kwong</u> suggested that each candidate should brief members how he or she would chair the meetings of the Bills Committee. As there were divided views among members, a vote was taken on Mr CHEUNG's suggestion. 12 members voted in favour of the suggestion while 25 members voted against.
- 4. Mr MAK Kwok-fung said that his name was not on the membership list of the Bills Committee. He further said that his assistant had confirmed having faxed his reply slip for joining the Bills Committee to the Legislative Council Secretariat. The Clerk said that the Secretariat had not received the reply slip from Mr MAK for joining the Bills Committee nor any telephone call from Mr MAK's office relating to the matter. Mr Kenneth TING, presiding member who had the highest precedence among members present, decided that Mr MAK's request for joining the Bills Committee would be dealt with after the Chairman of the Bills Committee was elected.
- 5. The Bills Committee took a vote to elect the Chairman of the Bills Committee. Mr IP Kwok-him was elected as Chairman by a majority vote of 30 to 14.
- 6. The Bills Committee then took a vote on Mr MAK Kwok-fung's request to join the Bills Committee. Mr Martin LEE requested that the names of members who voted be recorded.

7. The following 26 members voted in favour of the request -

8. The following five members abstained from voting -

Mr NG Leung-sing, Mr WONG Yung-kan, Mr YEUNG Yiu-chung, Miss CHOY So-yuk and Mr TAM Yiu-chung.

- 9. No member voted against the request. The Bills Committee decided that Mr MAK's request for joining the Bills Committee be acceded to.
- 10. The Bills Committee proceeded to elect the Deputy Chairman of the Bills Committee. Mr Ambrose LAU and Miss Margaret NG were respectively nominated by Dr David CHU and Mr James TO as candidates for the Deputy Chairman of the Bills Committee. A vote was taken and Mr Ambrose LAU was elected as Deputy Chairman by a majority vote of 27 to 13.

II. Meeting with the Administration and dates of subsequent meetings

- 11. The Bills Committee agreed that the next meeting be held on 25 March 2003 from 8:30 am to 10:30 am.
- 12. The Bills Committee also considered whether another meeting should be held on 27 March 2003 at 8:30 am. As there were divided views among members, a vote was taken. 19 members voted in favour of the Bills Committee holding a meeting on 27 March 2003, while 13 members voted against. The Chairman concluded that a meeting of the Bills Committee would be held on 27 March 2003 from 8:30 am to 10:30 am.
- 13. The meeting ended at 10:40 am.
