## I. Meeting with the Administration

The Bills Committee deliberated (index of proceedings attached at **Annex**).

2. The Bills Committee requested the Administration to provide a written response to the following issues raised and information sought by members -

### Sedition

(a) to consider adding the word "knowingly", "intentionally" or "wilfully" after the word "he" in the proposed section 9A(1) of the Crimes Ordinance (CO);

- (b) to consider deleting the proposed section 9C of CO;
- (c) to consider extending the protection in the search and seizure of journalistic materials in the proposed section 18B(5) of CO to academics, librarians, non-government organizations and financial analysts;
- (d) to consider defining the term "publishes" in the proposed section 9C(2)(a) of CO having regard to the explanation of "author", "editor" and "publisher" in section 3(3) of the United Kingdom (UK) Defamation Act 1996;
- (e) to consider deleting the term "likely" in the proposed section 9C(1) of CO and substituting "most likely";
- (f) to provide information on the relevant legislation in UK or constitutional instrument which, before Reunification, empowered the Legislative Council to enact legislation with extra-territorial effect;
- (g) to explain the application of the proposed section 9A(1)(b) of CO outside Hong Kong and the authority for the proposed section to apply to a Hong Kong permanent resident who was a foreign national, and to clarify the limits of the "nexus principle";

### Investigation power

- (h) to consider the suggestion of the Hong Kong Bar Association that the direction by a Police officer of or above the rank of chief superintendent of police under the proposed section 18B(1) of CO should be given in writing and a copy of the written direction should be shown to or left with the person affected;
- (i) to consider amending the proposed section 18B(4) of CO along the line of section 52(1)(f) of the Dangerous Drugs Ordinance (Cap. 134) that a person might be searched only if there was reason to suspect that the person was involved in an offence under the proposed section; and
- (j) to consider introducing a time limit on the detention of conveyance under the proposed section 18B(2)(e) of CO, having regard to the latest proposed Committee Stage amendments to clauses 15 and 16 of the Chemical Weapons (Convention) Bill.

- 3. The Bills Committee requested the Legal Adviser -
  - (a) to provide information on the investigation and search powers in CO as amended by the Bill, with particular reference to the Crimes (Amendment) (No. 2) Ordinance 1997; and
  - (b) to write to the Administration setting out the Legal Service Division's views on the Administration's paper on the interpretation, application and enforcement of the Bill (Paper No. 16).
- 4. The Bills Committee requested the Clerk -
  - (a) to provide the Administration with information on the deliberations of the Bills Committee on Chemical Weapons (Convention) Bill relating to the time limit for detention of conveyance; and
  - (b) to seek the views of the Judiciary on the time needed for obtaining a search warrant from a magistrate outside office hours, which, according to the Administration, would in general be over three hours, and whether there were any means to further shorten the time required for the issue of a search warrant, and whether there would be magistrates dealing with applications for search warrant at all hours.
