## I. Meeting with the Administration

The Bills Committee deliberated (index of proceedings attached at **Annex**).

2. The Bills Committee requested the Administration to provide a written response to the following issues raised and information sought by members -

#### **Sedition**

- (a) to provide information on the number of prosecutions against incitement in Hong Kong;
- (b) to provide information on the background for the enactment of the existing time limit of six months in section 11 of the Crimes Ordinance (CO) for prosecution against sedition-related offences;

- (c) to explain whether the terms "incite" and "incitement" in sections 6 and 7 of CO were to be construed in accordance with their meaning under the common law;
- (d) to explain whether the proposed offences in the new sections 9A(1) and 9C of CO were beyond the requirements of Article 23 of the Basic Law on sedition;
- (e) to provide the names of American lawyers who provided views on the "clear and present danger" test in the United States;
- (f) to consider amending the terms "members of the public" and "lawful means" in the proposed section 9D(3)(c) of CO to "any person" and "non-violent means" respectively; and

## **Investigation power**

- (g) to explain the inadequacies of the existing investigation power under the Police Force Ordinance (Cap. 232) and the need for the investigation power in the proposed section 18B of CO.
- 3. <u>Secretary for Security</u> stressed that the power conferred by the proposed section 18B of CO would be exercised under restricted conditions. The proposed section would not empower the Police to search any premises, place or conveyance at will. The Administration would consider the suggestion of the Hong Kong Bar Association that the direction by a Police officer of or above the rank of chief superintendent of police under the proposed section should be given in writing and a copy of the written direction should be shown to or left with the person affected.

### II. Any other business

- 4. The Bills Committee agreed that the note from Hon Emily LAU and Hon LEE Cheuk-yan on the categorization of submissions on the Consultation Document on Proposals to implement Article 23 of the Basic Law would be dealt with at the next meeting.
- 5. The meeting ended at 6:30 pm.
