I. Meeting with deputations and the Administration

The Bills Committee deliberated (index of proceedings attached at **Annex**).

- 2. The Bills Committee received the views of the following deputations on the Bill
 - (a) The Hong Kong Construction Association;
 - (b) Hong Kong & Kowloon Electrical Engineering & Appliances Trade Workers Union;
 - (c) Hong Kong Air-Conditioning and Refrigerating Trades Workers General Union;
 - (d) Neonsign Advertising Employees' Association;
 - (e) Hong Kong Electrical and Mechanical Management and Professional Association;
 - (f) Union of Hong Kong Electrical Engineering Assistants; and
 - (g) The Federation of Hong Kong Electrical & Mechanical Industries Trade Unions.
- 3. <u>The Bills Committee</u> noted that having considered members' views, the Administration would propose a Committee Stage amendment to the proposed new section 7(1)(j) of the Industry Training (Construction Industry) Ordinance (ITCIO) to specify that one of the Construction Industry Training Authority (CITA) Board

members would be a representative of an electrical and mechanical (E&M) trade union in the construction industry.

- 4. <u>The Bills Committee</u> requested the Administration to provide a written response on the following -
 - (a) to consider providing an undertaking by the Secretary for Education and Manpower in his speech delivered during the resumption of Second Reading debate on the Bill that the fee charging principle adopted by CITA for determining the test fee for E&M trade tests would be the same as that for the fees of the construction trade tests:
 - (b) to consult the Hong Kong Institution of Engineers on the proposed revision of the composition of the CITA Board i.e. proposed amendments to section 7(1)(e) and (f) of ITCIO;
 - (c) to review the drafting of paragraph 2 of the proposed schedule 1 to ITCIO to reflect more clearly the policy intent; and
 - (d) to respond to the issues raised by the legal adviser to the Bills Committee in her letter dated 6 October 2003 to the Administration.
- 5. <u>The Bills Committee</u> agreed that it would start the clause-by-clause examination of the Bill at the next meeting.

- 6. <u>Members</u> agreed that the next two meetings would be held on 30 October 2003 at 10:45 am and 10 November 2003 at 4:30 pm.
