#### Members' Motions

## "Local Agenda 21" and sustainable development

Hon CHOY So-yuk moved the following motion and addressed the Council:

That this Council urges the Government to actively respond to the spirit of the Earth Summits convened by the United Nations sustainable development in 1992 and 2002 expeditiously implement the relevant agreements on sustainable development, including formulating and implementing strategies for sustainable development, a "Local Agenda 21" and action plans; to this end, the Government should set up the Council for Sustainable Development as soon as possible, commence dialogues with different sectors of society, including nongovernmental organizations, District Councils, local groups and private organizations, so as to work out a package of specific strategies, agendas, goals and timetables that suit local circumstances, provide sufficient resources, devise a mechanism for public participation, implement action plans, and to report to the public regularly on the progress and achievements of its work.

Question on the motion proposed.

Two Members and Hon CHAN Kwok-keung spoke on the motion.

While Hon CHAN Kwok-keung was speaking, the President left the chair at 4:45 pm temporarily and the President's Deputy, Hon Mrs Selina CHOW, took the chair.

Another 10 Members and the Chief Secretary for Administration spoke on the motion.

At 5:45 pm, while the Chief Secretary for Administration was speaking, the President resumed the chair.

Hon CHOY So-yuk replied.

Question on the motion put and agreed to.

### Reducing transport fares

Hon Andrew CHENG moved the following motion and addressed the Council:

That, in view of the enormous transport expenses borne by the public, this Council urges the Government to discuss with various public transport operators with a view to reducing expeditiously the fares of transport services and, at the same time, establishing a fare adjustment mechanism, so as to alleviate the burden on people's livelihood.

Question on Hon Andrew CHENG's motion proposed.

The President stated that Hon LAU Kong-wah would move an amendment to the motion and that Hon WONG Sing-chi would also move an amendment to Hon LAU Kong-wah's amendment. In accordance with the Rules of Procedure, the motion, the amendment, and the amendment to the amendment would be debated together in a joint debate.

Hon LAU Kong-wah moved the following amendment to Hon Andrew CHENG's motion and addressed the Council:

To add ", to request these operators to offer further concessions, including: (a) the Kowloon-Canton Railway Corporation and the MTR Corporation Limited taking the lead in reducing fares; (b) co-operation of the various transport operators in offering joint concessions; rationalization by bus companies of any unreasonable fare structures of their circular routes, cross-harbour tunnel routes, express routes and those routes served by airconditioned buses, and the introduction of more section fares long-distance routes; (d) promoting monthly ticket schemes; and (e) reintroducing half-fare travel concessions for students;" after "this Council urges the Government to discuss with various public transport operators with a view to reducing expeditiously the fares of transport services"; and to delete "establishing" after "at the same time," substitute with "to establish".

Question on Hon LAU Kong-wah's amendment to Hon Andrew CHENG's motion proposed.

Hon WONG Sing-chi moved the following amendment to Hon LAU Kong-wah's amendment and addressed the Council:

To add "introducing and" after "(d)"; to add "one-day and one-week travel pass schemes and" after "promoting"; to delete "and" after "monthly ticket schemes;"; and to add "and (f) providing comprehensive fare concessions for the elderly;" after "(e) reintroducing half-fare travel concessions for students;".

Question on Hon WONG Sing-chi's amendment to Hon LAU Kong-wah's amendment proposed.

Three Members spoke on the motion and the amendments.

Hon Eric LI declared his interest as an independent and non-executive director of the Kowloon Motor Bus Holdings Limited and spoke on the motion and the amendments.

Another 13 Members spoke on the motion and the amendments.

Hon Andrew CHENG spoke on the amendments.

The Secretary for the Environment, Transport and Works spoke on the motion and the amendments.

Question on Hon WONG Sing-chi's amendment to Hon LAU Kong-wah's amendment put.

Hon Howard YOUNG claimed a division. The President then ordered the Council to divide under Rule 47(1) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 22 were present, 10 were in favour of the amendment, six against it and six abstained; while among the Members returned by geographical constituencies through direct elections and by the Election Committee, 22 were present, 20 were in favour of the amendment and one against it. (Voting record in Appendix I.) Since the question was not agreed by a majority of each of the two groups of Members present, she declared that Hon WONG Sing-chi's amendment to Hon LAU Kong-wah's amendment was negatived.

Hon Mrs Selina CHOW rose to move the following motion without notice:

That in the event of further divisions being claimed in respect of the remaining motions to be moved to the motion on Reducing transport fares at this meeting, Rule 47(1)(c) of the Rules of Procedure be suspended so that the President may order that the Council do proceed to each of such divisions immediately after the division bell has been rung for one minute.

Question on the motion proposed, put and agreed to.

Question on Hon LAU Kong-wah's amendment to Hon Andrew CHENG's motion put.

Hon Howard YOUNG claimed a division. The President then ordered the Council to divide under Rule 49(5) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 22 were present, 10 were in favour of the amendment, six against it and six abstained; while among the Members returned by geographical constituencies through direct elections and by the Election Committee, 22

were present, 20 were in favour of the amendment and one against it. (Voting record in Appendix II.) Since the question was not agreed by a majority of each of the two groups of Members present, she declared that Hon LAU Kong-wah's amendment to Hon Andrew CHENG's motion was negatived.

Hon Andrew CHENG replied.

Question on Hon Andrew CHENG's motion put.

Hon Kenneth TING claimed a division. The President then ordered the Council to divide under Rule 49(5) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 22 were present, 10 were in favour of the motion, six against it and six abstained; while among the Members returned by geographical constituencies through direct elections and by the Election Committee, 22 were present, 20 were in favour of the motion and one against it. (Voting record in Appendix III.) Since the question was not agreed by a majority of each of the two groups of Members present, she declared that the motion was negatived.
