EC(2002-03)10 Proposed merger of Government Land Transport

Agency, Government Supplies Department and Printing Department into a new Government Logistics Department with effect from 1 July 2003

for better efficiency and economy

Members noted that the Panel on Financial Affairs had been consulted on the present proposal on 6 January 2003.

- 2. In reply to Mr TAM Yiu-chung's enquiry about the timetable for the deletion of the 59 non-directorate posts as a result of the proposed merger and other changes in operational requirement, the Permanent Secretary for Financial Services and the Treasury (Treasury) (PSTsy) said that the 59 posts expected to be deleted were mainly in the general grades and in surplus departmental grades. He expected that the posts in question could be deleted through natural wastage, retirement and re-deployment in two to three years' time.
- 3. On Ms LI Fung-ying's enquiry regarding the arrangements for the incumbent postholders of the deleted posts, PSTsy advised that most of them would be laterally transferred to take up relevant posts in the newly merged department.
- 4. Mr TAM Yiu-chung asked whether the centralized procurement functions currently undertaken by the Government Supplies Department (GSD) would be devolved to individual departments and hence, have implications on manpower requirements. In reply, the Director of Government Supplies (DGS) explained that at present, bulk purchase was the most economical and cost-effective procurement method given that there was a common requirement among government departments for certain items such as computers, paper, office equipment, etc. It was thus unlikely that the purchase of such items would be devolved to individual departments. Nevertheless, there were Supplies Grade officers seconded to departments to assist in stores procurement.
- 5. Referring to the increasing use of on-line purchase in the business sector, Mr James TIEN asked whether the Government would adopt e-procurement to achieve greater savings in staff cost. In this connection, DGS informed members that at present, an Electronic Tendering System (ETS) was in place. All tenders originated by Government Supplies Department were posted on the ETS. Suppliers could submit bids electronically or paper based. However, not many bids had been received on-line. She further informed members that two trial runs on electronic marketplace involving ten government departments were implemented last year. For purchases below \$50,000, individual government departments were allowed to procure the items on-line. However, it was found that many of the items on sale at the e-marketplace were not commonly required Regarding concerns about manpower savings, by government departments. DGS said that during the last five years, the number of staff in GSD had been reduced from over 700 to around 300. The department would continue to be mindful of the need to deploy its manpower resources effectively having regard to improvements in technology.
- 6. In this connection, Mr Howard YOUNG commented that if the Government maintained an electronic and a conventional procurement system in parallel, it might not be able to achieve savings and might even require additional resources. Mr YOUNG also drew the Administration's attention to the prevalent

practice in some private-sector corporations that they would only accept on-line tender bids for bulk purchase. This would be useful in promoting the use of etendering. The Administration took note of his remarks.

7. The item was voted on and endorsed.

EC(2002-03)11

Proposed deletion of three permanent posts of one Chief Estate Surveyor (D1) in Lands Department, and one Government Town Planner (D2) and one Chief Town Planner (D1) in Planning Department with retrospective effect from 8 February 2003
