**I Confirmation of minutes**

(LC Paper No. CB(1)2147/02-03 - Minutes of meeting held on 19 June 2003)

1. The minutes of meeting held on 19 June 2003 were confirmed.

**II Meeting with the Administration**

(LC Paper No. CB(1)2148/02-03(01) - Information paper provided by the Administration)

2. The Subcommittee deliberated (Index of proceedings attached at **Annex A**).
3. The Subcommittee took note of the findings presented by the Administration on its surveys to review the effectiveness of the New Territories (NT) taxi temporary fare concession. The major findings were:
  - (a) there were increases in the average daily number of paid trips per NT taxi, the average daily paid kilometres (km) per NT taxi and the average

daily fare revenue per NT taxi in general during the period between 8 June and 3 July 2003 after the implementation of the fare concession;

- (b) there had been noticeable increase in long trips which were eligible for the concession whereas short trips (below 3.4 km) which were not part of the concession scheme registered a decline in ridership; and
- (c) about 80% of the respondents of the survey on the NT taxi trade did not agree to the continuation of the temporary fare concession.

*(Post-meeting note: A set of diagrams showing "Major Operating Statistics of NT Taxis (January 2003 - July 2003)" was tabled at the meeting by the Administration and subsequently issued to members vide LC Paper No. CB(1)2175/02-03(01).)*

4. The Subcommittee also noted the plan of the Administration on the way forward, and agreed that the Administration should seek the approval from the Chief Executive-in-Council to terminate the temporary fare concession as soon as possible.

5. The Subcommittee also noted the Administration's suggestion that in order to expedite the process, the temporary fare concession would be terminated the next day after gazettal of the relevant subsidiary legislation without waiting for the completion of the negative vetting period. Members agreed to the Administration's suggestion.

6. The Subcommittee reiterated their concern about certain aspects of the Administration's policy on the operation of the taxi trade, and agreed that the matter be referred to the Panel on Transport for follow up. Specifically, members expressed the following views for the Administration to consider:

- (a) The Administration should ensure the effectiveness of the communication mechanism for consultation with the NT taxi trade.
- (b) The Administration should review and improve its measures against illegal taxi touting practices which had seriously affected the interest of the law-abiding taxi operators. On the one hand, the offer of fare discount by drivers was prohibited by law while the bargaining of taxi fare by passengers was allowed although not encouraged. The Administration should consider introducing legislative amendments if necessary to address this anomaly.
- (c) The Administration should continue its enforcement actions against illegal touting practices including the offer of fare discounts by individual taxi drivers through the illegal use of radio transceivers and the distribution of discount cards to passengers. The Administration should consider issuing clear guidelines to taxi operators on whether and

in what circumstances would the distribution of name cards to passengers be allowed.

- (d) The Administration should also consider further measures to improve the business opportunities of the taxi trade, in particular allowing them to operate to boundary control points.

Admin 7. The Administration agreed to review the matter taking into account members' views, and revert to the Panel in due course.

Admin 8. At the Chairman's request, the Administration also undertook to provide supplementary information on the number of bookings made by Government departments for hourly-hired taxis under the Taxi Hiring Scheme in the past three months.

**III Any other business**

9. There being no other business, the meeting ended at 11:30 am.
