I. Election of Chairman and Deputy Chairman

<u>Mr IP Kwok-him</u> nominated Mr Andrew WONG as Chairman of the Panel. Mr NG Leung-sing seconded the nomination. <u>Mr Andrew WONG</u> accepted the nomination. 2. There being no other nominations, <u>Mr Andrew WONG</u> was elected Chairman of the Panel.

3. <u>Miss Margaret NG</u> nominated Ms Emily LAU as Deputy Chairman of the Panel. Mr Andrew WONG seconded the nomination. <u>Ms Emily LAU</u> accepted the nomination.

4. There being no other nominations, <u>Ms Emily LAU</u> was elected Deputy Chairman of the Panel.

II. Schedule of meetings for the 2002-2003 session

5. <u>Members</u> decided that the regular meetings of the Panel should be held at 2:30 pm on the third Monday of each month, subject to rescheduling as circumstances required.
