I. Election of Chairman and Deputy Chairman for the 2002-2003 session

Election of Chairman

<u>The Chairman</u> called for nominations for the chairmanship of the Panel for the 2002-2003 session. The Chairman was nominated by <u>Dr LO Wing-lok</u> and the nomination was seconded by Mr WONG Yung-kan. <u>The Chairman</u> accepted the nomination.

2. As the Chairman was nominated, Mr Tommy CHEUNG, the Deputy Chairman, presided over the election of the Chairman. As there was no other nomination, <u>Mr Tommy CHEUNG</u> declared Mr Fred LI elected as Chairman of the Panel.
