Further to my letter of 19 August 2003, I wish to advise that at the hearing on 26 August 2003, the Honourable Mr Justice Chung has ordered that there be a stay of execution of paragraph 1^{Note} of the Court Orders insofar as the implementation of paragraph 1 of the Court Orders requires Housing Authority to have the variation of rents so determined to take effect ahead of the conclusion of Housing Authority's appeal to the Court of Appeal on the judicial review, on the condition that Housing Authority undertakes to –

(a) prosecute with all expedition the appeal to the Court of Appeal; and

^{Note} This paragraph reads as follows : Without prejudice to the [Housing Authority's] right to conduct the rent review ordered by the Court in the same manner as [Housing Authority] has adopted in previous rent reviews, [Housing Authority] do and is hereby commanded to forthwith review and determine the variation of rents of the class (or batch) of public housing units to which the applicant's public unit is part, according to the true meaning and effect of section16(1A), Housing Ordinance (Cap 283).

(b) review the rents of the public housing units to which paragraph 1 of the Court Orders applies and to determine the variation of rents of such public housing units in accordance with the terms of paragraph 1 of the Court Orders while the appeal is underway.

Members may also wish to note that the Housing Authority submitted its grounds for appeal on 25 August 2003.
